### 1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

### 2. Approval of the October 15<sup>th</sup>, 2024, Public Safety Committee Minutes

The minutes were approved unanimously.

### 3. NYPD Report (\*See attached NYPD CompStat Report) –

Lieutenant Wolvers presented the NYPD CompStat report. Detective Jamsheer was present. Issues discussed:

- Reports of a deli on 235<sup>th</sup> Street & Johnson Avenue selling illegal cigarettes.
- Death in Van Cortlandt Park on 11/3/24. Unidentified man discovered hanging from a tree in an apparent suicide.
- 32 arrests made for multiple car break-ins throughout the area.
- Recidivist criminals continue to be arrested and immediately released due to bail reform laws.

- Drug dealing reported at 238th Street and Bailey Avenue. Several arrests have been made at this location. 50th Precinct will continue to monitor.
- Inquiry about number of NYPD officers assaulted in the line of duty. No statistical information available.
- Overnight drug trafficking reported at the south end of Steven Place towards Sedwick Avenue in the loop behind the Van Cortland Jewish Center. 50th Precinct will investigate.
- Resident complaint about car wheel and airbag thefts in Riverdale alongside Henry Hudson Parkway.
- Psychiatric care for mentally ill criminals. Lack of public resources.
- Are level 1 stops reports (Local Law 586) affecting police response times to incidents? No information currently available. Public awaiting release of agency data.
- Gang fights reported at the IN-Tech Academy (M.S. / High School 368) located at 2975 Tibbett Avenue. No arrests made.
- Car covered by tarp, propped up on milk crates at 227-232 Arlington Avenue. Appears abandoned.

#### 4. FDNY Report

Battalion Chief Greg Lehr presented the FDNY report, including a statistical overview of area fires. Committee discussion included:

- Various brush fires occurring recently in Van Cortlandt Park. Arson not suspected. Causes unknown.
- Public education campaigns about forest fires have decreased significantly over the years.
- Promoting information about e-bike storage and lithium-ion battery charging.
- FDNY has resources to determine toxicity levels of suspicious chemicals.

The 50<sup>th</sup> Precinct provided a statistical list of 911 & 311 calls in the last 12 months surrounding this establishment, that included assault, robbery, stabbing, firearm & harassment.

C.O. Captain Pierce and the Officers in attendance recommended this business be denied an all-night permit, citing past disturbances surrounding the establishment, the 50<sup>th</sup> Precinct's lack of available officers on New Years Eve and his concern for public safety in the area.

The Public Safety Committee unanimously disapproved this application.
