The nominations are open to individuals, organizations, or groups with a civic interest in the community. Those who are salaried for their efforts or who perform these services as an extension of their studies or professional responsibility are not eligible for this award.

Volunteers have given of their free time in many ways to improve the life of our community. Previous community service awardees volunteered to support people who are unhoused or disabled. Some awardees worked to improve our environment, our parks or our streets. Others contributed to enhancing educational and cultural opportunities for young people.

Nominations must be received by Friday, March 21, 2025, and should include:

- Description and nature of the **volunteer** work for which the nominee is being considered
- Name of the person or organization making the nomination, including contact information
- No self-nominations
