#### Report from the NYPD 50th Precinct

Year-to-date, down by 30% in crime. 16% decrease in crime for the 28 day-period. 50% reduction in robberies, 30% reduction in grand larcenies and 6% reduction in grand larceny autos (GLAs). GLAs, tire and rim thefts have been one of the major issues that the community has been experiencing, and those are down pretty significantly this year. Burglaries have increased – 11 vs. 5. No hate crimes for the year. No shootings this year.

# NYC Council Member's (CM) Report

# NYC Council Member (CM) Pierina Ana Sanchez's Office:

The office is located at 2065 Morris Avenue, Bronx, New York 10453 and the phone number is 347-590-2874. Services provided include immigration assistance, housing assistance, etc. The office was helping the victims of the fire from 3030 Heath Ave.

*NYC Council Member (CM) Carmen De La Rosa:* No report.

#### NYC Council Member (CM) Rafael Salamanca, Jr.:

Kudos to how effective Bronx Community Board 8 is. Local Law 97 (LL97) is a New York City law that limits greenhouse gas emissions from large buildings. Because there is a lot of questions and concerns on what this law actually does, the office is partnering with Con Edison and the New York State Energy Research and Development Authority (NYSERDA) to host a Zoom call on February 18 at 5:30 pm to give the community an opportunity to address what this law is actually going to do for you.

There is a yellow box on the crosswalks, and you press the button and it makes noise. This is called an "Accessible Pedestrian Signal" (APS), designed to alert visually impaired people when it's safe to cross the street by providing an audible cue when the walk signal is activated; pressing the button initiates the sound signal. CM Salamanca, Jr. drafted and passed this law for the City so that an Accessible Pedestrian Signal (APS) is installed at every crosswalk that has a traffic light. Bronx Community Board 8 is an area where it is not in compliance.

CM Salamanca, Jr. is also the Chair of the NYC Council Land Use Committee. The Board voted against the *City of Yes for Housing Opportunity*. This plan allows for areas to do their fair share in building housing in the City. There are concerns in low density areas where they are going to take the block and build bigger. But there are restrictions within that. The *City of Yes for Housing Opportunity* does not take away the power from a Council Member when it comes to negotiating when there is a new development being proposed in the area. The Land Use Division in the NYC Council is accessible and CM Salamanca, Jr. will speak with CM Dinowitz and CM Sanchez to see if there is interest to hold an info session with the Land Use Division regarding the *City of Yes for Housing Opportunity*.

CM Salamanca, Jr. will look into the eight private homes in Van Cortlandt Village that are being converted internally into multiple use dwellings.

#### **Treasurer's Report & Resolutions**

The total budget is \$276,915 and it is broken down by Personal Services (PS) and Other than Personal Services (OTPS). The total OTPS budget is \$25,483 and there is \$13,225 left in the OTPS budget. A breakdown of the various object codes in the OTPS budget was announced. No budget modifications this month. \$0 in requested funds and \$0 in encumbered funds. \$2,065 remains in the Rent and Energy Detail.

#### **Chairperson's Report & Resolutions**

Due to the current issues concerning the rights of migrants in our community, the Community Board is working to put a community forum to give information to the community on what their rights are. Thank you to Board Member B. Bender for taking the lead on this important issue. On short notice, we invited elected officials to discuss the migrants' rights. Thank you to those in attendance including Council Member Dinowitz, and representatives from the offices of Council Member Sanchez, Public Advocate Williams, Senator Rivera and Assembly Member Alvarez. We will be meeting with Council Member De La Rosa later this week. We are looking to hold the community forum right before the next Board meeting. Discretionary budget is ongoing and we will continue to submit requests. If anyone has any items that we could possibly include, please let us know.

Our intern Jaylyn Adorno finished last week. Thanks to past Board Member and current Hunter College Professor Jillian Baez, we now have another intern for two months, Deonte Dewar. Welcome, Deonte!

The Ad-Hoc Committee composed of Board Members J. Townes and K. Walker that will explore committee memberships and structures will attend the Law, Rules & Ethics Committee to present their findings and then present at the Executive Committee.

When we discuss the Community Board 8 Awards and voting on what the procedures are, Board Members should have a clear vision that these awards are coming from the Board. Make sure the awards have a purpose and criteria. We have time to put it together but put some thought into it when having discussions.

In 2027 and 2028, many of the Board Members will be term limited. Ask the newer Board Members to get more involved and really think about what committees you may want to chair in the future. Elections are coming up in May and ask the current chairpersons of the committees to start mentoring Board Members.

After serving 17 years on the Board, one of our most committed Board Members has resigned. Serving as the Chairperson of the Law, Rules & Ethics Committee for 2 years, the Parks & Recreation Committee Chairperson for 2 years, the Vice Chairperson of the Board for 3 years, and then as the Chairperson of the Board for 3 years, as well as the Housing Committee Chairperson for a year afterwards, thank you Rosemary Ginty for all the work and commitment she has given to the Board and community. She shared her vast knowledge with all and will truly be missed.

#### NYC Council Member (CM) Eric Dinowitz's Report

Thank you to former Board Member Rosemary Ginty for her work and years of service in the Community Board. Because of Rosemary, and people like Rosemary, CM Dinowitz voted against the *City of Yes for Housing Opportunity*.

Passed a couple of bills in the NYC Council:

- Legislation to require the 311 system to provide customer satisfaction surveys after a case is closed. In these surveys, you will be able to provide both qualitative and quantitative information, and if necessary, reopen your case. This data will be published monthly, providing much-needed transparency on the responsiveness of our city agencies and equipping the NYC Council with more tools to hold our city agencies accountable when they fail to address safety and quality-of-life needs effectively.
- A resolution to recognize January 27, 2025, as the 80th anniversary of the liberation from Auschwitz-Birkenau. This resolution also establishes January 27 of every year as Auschwitz Remembrance Day in New York City.

CM Dinowitz will host an informative session on February 13 at 6:00 p.m. to 7:30 p.m. on Local Law 97 (LL97) requirements and best practices through presentations from NYC Accelerator, Con Edison, and NYSERDA.

Participated in the annual HOPE Count (Homeless Outreach Population Estimate), a citywide initiative to survey and support our unsheltered neighbors. Thank you Board Member D. Gellman for joining us.

Meeting with community leaders, including religious leaders, canvassing businesses to put up informational flyers, planning informational webinars, and handing cards and pamphlets directly to those who may be impacted by the new immigrant policies.

#### District Manager's (DM) Report

FY2026 Community District Needs Statement has officially been released and sent the agency responses. It has been posted on our homepage and emailed to all of Board Members. Hard copies have been made for the Committee Chairs.

Held the District Service Cabinet (DSC) meeting on February 4<sup>th</sup>. The next DSC meeting is on March 4<sup>th</sup>.

Met with the MTA on February 10<sup>th</sup> on accessibility projects for their 5 year 25-29 capital plan. The West 242nd station is currently underway and will be completed in 2026. Advocated for the Marble Hill West 225th station to be part of the next group of stations that get handicap accessible upgrades (Three stops in between, NYCHA, commercial corridor, near the metro North Station)

It was Jaylyn's (intern) official last day on January 31, 2025. Hoping to continue with her but thank her for her hard work, dedication to finishing the projects and overall pleasant demeanor. She was a welcome addition to our office and helped do many projects to assist the office in our organization and outreach.

It is Black History Month and want to wish a Happy Lunar New Year to those that celebrate. Our office will be closed for President's Day on Monday, February 17<sup>th</sup>.

Now with FY 2027 (in that cycle now), the committees have done a good job by adding the FY 2027 capital and expense budget priorities on their agendas for January and February. Full discussion on them in February, prioritizing them in March, and turning them in by April 20.

**b)** <u>Economic Development –</u> Held a meeting last Tuesday, February 6<sup>th</sup>. Sending out the press release for the Betty Campbell Adams Most Valuable Merchant Award on February 15<sup>th</sup>. The nomination period will be from February 15<sup>th</sup> to March 15<sup>th</sup>. Merchants can self-nominate. The next meeting will be held at one of the local businesses (to be determined) in the District.

**c)** <u>Education, Libraries & Cultural Affairs –</u> Contacted the principals of the local schools in our District regarding the FY27 budget items. The response has been much better than in past years. Encouraged that they are letting us know what the needs of their schools are. The next meeting will be on February 25<sup>th</sup>.

**d)** <u>Environment & Sanitation –</u> The last meeting was on January 15<sup>th</sup> and the NYC Department of Sanitation (DSNY) did not attend. Hoping they attend the next meeting on February 19<sup>th</sup> to talk about snow removal in the district.

A SNAD 105-421 Authorization to facilitate a 60 sq. ft. enlargement at the west side of the first floor of the house, including kitchen, patio, and porch extension with a new 4ft pool is being sought by private applicant, Khanna Schultz Architecture and Design at 5445 Palisade Avenue in North Riverdale, Community District 08, Bronx, NY.

**WHEREAS,** the Architect confirmed no existing trees or topography will be removed or affected by the project and Ken Almstead, a certified Arborist, submitted a letter as requested by the committee confirming there will be no impact on the existing trees, and

**WHEREAS,** the project is guided by principals of conservation and ecological enhancement, and

**WHEREAS,** no construction will occur on the steep downslope area that comprises 60% of the property and no intrusion onto the Metro North Station area, and

**WHEREAS,** the building constitutes a total of 19 % of the lot area, and natural developed area is 81% of the property, and

**WHEREAS,** the applicant, Ainsley Perrien, informed all neighbors within 200 feet of the property, and,

**WHEREAS,** no opposition was indicated either from the board or from the community.

**WHEREAS,** for the reasons set forth above, the Land Use Committee unanimously APPROVED this application.

# The resolution to <u>APPROVE</u> the 5445 Palisade Avenue-SNAD Non-ULURP 2025X0153 application <u>PASSED UNANIMOUSLY</u>.

There are eight private homes in Van Cortlandt Village that are being converted internally into multiple use dwellings, as much as 10 apartments in one house. Asked the NYC Department of Buildings (DOB) what the intention was for these buildings and gotten no response. Will send CM Salamanca, Jr. the list of the addresses of these homes to further look into it.

Rumors have been going around regarding who will be moving into the development being built at 160 Van Cortlandt Park South. At various Land Use Committee meetings, Tishman Speyer, the developer, stated the units will be for affordable housing. We have an impression it will be affordable housing and not transitional housing. In an effort not to spread any further rumors, Tishman Speyer and HPD representatives will attend the next Land Use Committee meeting for review and follow-up questions on the affordable housing development at 160 Van Cortlandt Park South.

**h)** <u>Law, Rules & Ethics –</u> The committee looked over the meeting minutes of the various committees offering awards and felt that the committees have done excellent jobs in trying to define what these awards are. Still have some suggestions which have been relayed to the various Chairs for them to consider. Looked at a number of items before the state

legislature that concern the Open Meetings Law. There is proposed legislation for quorum to be a one plus a quarter of the membership (compared to now which is one plus half of the membership). There is also a move that the whole concept of Zoom meetings made sense and people shouldn't necessarily be at meetings in-person, only the Chair or the presiding officer needs to be present in-person. There are competing resolutions that the Community Board Members ought to be required to take hours of trainings on the Open Meetings Law / Freed of Information Law (FOIL). The committee did not take any position on these. Please read the committee's minutes and if you have any opinions on these matters, the committee would love to hear from you.

i) <u>Parks & Recreation –</u> NYC Department of Environmental Protection (DEP) presented on the final plan of the Tibbetts Greenway. The NYC Department of Parks and Recreation (DPR) and NYC Department of Transportation (DOT) were also in attendance to answer any questions as they came up. Tibbetts Brook will be daylighted below the Van Cortlandt Park and will go down to somewhere just short of 230<sup>th</sup> Street which will go down to a pipe to be released into the Harlem River. The next meeting will be held on February 26<sup>th</sup> and the major item that will be discussed is the Van Cortlandt Park Master Plan.

Bender proposed a friendly amendment for the resolution to remove of one of the *Whereas* clauses, "WHEREAS, the United States Consumer Product Safety Commission reports there were 104 fatalities and 53,200 emergency room visits associated with e-bikes and 111 fatalities and 169,300 emergency room visits associated with e-scooters from 2017-2022." Friendly amendment to remove this *Whereas* clause accepted by E. Green.

E. Green presented the below resolution, as amended:

#### PUBLIC SAFETY COMMITTEE RESOLUTION SUPPPORT FOR PRISCILLA'S LAW (NYC COUNCIL INTRO BILL 606)

**WHEREAS,** there has been a massive increase in e-bike ridership since their legalization in 2020, NYC Councilmember Robert Holden has introduced Priscilla's Law (Intro Bill 606) sponsored by 29 Councilmembers, including Councilman Eric Dinowitz, and is supported by NYC Mayor Eric Adams and the NYC E-Vehicle Safety Alliance.

**WHEREAS,** Priscilla's Law (Intro Bill 606) is "a Local Law to amend the administrative code of the city of New York, in relation to requiring that every bicycle with electric assist, electric scooter and other motorized vehicle be licensed and registered by DOT and receive an

*identifying number which would be displayed on a visible plate affixed to the vehicle." (Medical mobility scooters are exempt).* 

**WHEREAS,** the law is named after Priscilla Loke, a beloved 68-year-old HeadStart Teacher, who was run down and killed by an e-biker as she walked to work in Chinatown in September of 2023.

**WHEREAS,** Bronx Community Board 8 Public Safety Committee has received persistent resident complaints about speeding e-bikes and scooters operating recklessly on sidewalks, running red lights, ignoring crosswalks, and going the wrong way down one-way streets, creating dangerous conditions for motorists, cyclists and pedestrians.

**WHEREAS**, the 50<sup>th</sup> Precinct has reported that e-bikes have been used in Van Cortlandt Park and elsewhere to facilitate robberies and other criminal activity, and registration can assist Park PEP Officers to identify law-breakers.

**WHEREAS,** since the City Council legalized e-bikes and scooters in 2020, 10 pedestrians, 33 cyclists and 3 motorists have been killed (46 total) and 979 pedestrians, 2,573 cyclists and 500 motorists have been injured (4,052 total) in crashes involving e-bikes and scooters (as per city data: NYC Crash Mapper - 2/10/25)

**WHEREAS,** unlike e-bike identification stickers required by businesses, surveillance cameras can record images of e-bike license plates, making often dangerous police chases unnecessary, and traffic violations easier to enforce.

**WHEREAS,** data from other countries and cities indicate that when motorized transportation devices are registered, licensed and insured - fatalities and injuries decrease dramatically (ex. 29% fewer deaths, 64% fewer crashes in Denmark).

**WHEREAS,** sponsors of the bill state that e-bike batteries have been responsible for over 735 battery fires resulting in 500 injuries and 30 deaths since 2019, and mandatory licensing and registration would help identify owners of e-bikes involved in fires.

**WHEREAS**, the IDNYC Program issues ID to all New Yorkers for health benefits, housing, employment, etc., regardless of immigration status, thus enabling undocumented immigrants to obtain proper identification for registration.

**WHEREAS,** sponsors of the bill advocate for free registration or minimal cost in order to reduce financial burdens.

**WHEREAS,** the Bronx Community Board 8 Public Safety Committee believes Priscilla's Law (Intro Bill 606) will improve public safety by providing accountability, serve as a deterrent to reckless traffic violators, and prevent numerous injuries and fatalities.

**THEREFORE, BE IT RESOLVED**, Bronx Community Board 8 supports Priscilla's Law and urges the New York City Council to pass Intro Bill 606 into law.

**BE IT FURTHER RESOLVED**, Bronx Community Board 8 requests funds be allocated in the city budget to provide resources for its implementation while addressing concerns of the migrant and business communities.

**Whereas,** the Borough President's Office advised after January 14, 2025, that the District Manager's current salary is \$99,250; and

Whereas, the below is now submitted in place of the January 14, 2025 Resolution:

**Whereas,** Bronx Community Board 8 (CB8) voted unanimously on May 9, 2023, to approve the hiring of Farrah Kule Rubin as the District Manager; and

Whereas, Ms. Rubin's start date was June 5, 2023; and

**Whereas,** the annual salary for the newly hired District Manager was set at \$95,000 per year; and

**Whereas,** The Mayor's Office granted a 1.43% Mayor's Recruitment, Retention & Merit increase to Ms. Rubin February 2024; and

**Whereas,** On January 14, 2025 the Community Board voted unanimously for a 10% salary increase for Ms. Rubin bringing the annual salary to \$104, 500; and

**Whereas,** the Borough President's Office advised after January 14, 2025 that the District Manager current salary is \$99,250; and

**Whereas,** the Bronx Borough President's office has been advised of the discrepancy in salary and will advise OMB and the Board office of findings; and

**Whereas,** the New York City Mayor's Office of Management & Budget (OMB) has reviewed CB8's budget on more than one occasion, as recently as February 3, 2025, and advises the requested salary increase is within the Board's budget at the announced current salary of \$99,250; and

**Whereas,** Ms. Rubin was hired at a time with limited personnel to train her and she was immediately inundated with an unexpected heavy workload at the start; and

**Whereas,** Ms. Rubin quickly adapted and became extremely familiar with Community Board operations and the New York City Charter; and

Whereas, Ms. Rubin has satisfactorily completed over 18 months' employment; and

**Whereas,** throughout her employment Farrah Kule Rubin has satisfactorily performed her assigned duties and exceeded expectations on many occasions; and

Whereas, Ms. Rubin makes herself available beyond working hours if needed; and

**Whereas,** Ms. Rubin's assigned, new, and self-expanded duties include, but are not be limited to, managing day-to-day operations, host monthly District Service Cabinet (DSC) meetings, producing quarterly newsletters, increasing Community Board presence by attending community events, monitoring CB8 social media sites, takes initiative to start and attend new events within the CB8 district, keeps abreast of the various agency protocols and policies, provide input of Budget priorities and Statement of Needs for CB8, interacts with elected officials and the public, administrative duties on the computer, attends and tables street fair events, keeps the community and Board members informed; and

**Whereas,** Community Board 8 adopted a resolution on February 9, 2010, that requires any decision concerning internal operating budgets be made by the Chairperson in consultation with the Board officers and brought to the Community Board for "ratification, amendment or rejection,"; and

**Whereas,** the Community Board Chairperson and the Treasurer recommend that the salary increase be set at 10%; and

Whereas, this decision is concurred by the Vice Chairperson and the Secretary; and,

**Whereas,** this decision was brought before the Executive Board on January 8, 2025, and consensus was agreeable to the salary increase amount; and

**Whereas,** the New York City Mayor's Office of Management & Budget (OMB) has reviewed CB8's budget on February 3, 2025, and advises the requested salary increase is within the Board's budget at the announced current salary of \$99,250; and

**Therefore, Be it Resolved,** that the January 14, 2025, Resolution be amended to note that the 10% salary increase will be on an annual salary of \$99,250; and

**Therefore, Be it Further Resolved,** Bronx Community Board 8 approves the 10% salary increase for District Manager Farrah Kule Rubin effective retroactive to January 14, 2025, adjusting the annual salary of \$99,250 per year to \$109,175.
