Chair Ed Green called the meeting to order at 7:00pm

#### 1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

#### 2. Approval of the February 18th, 2025, Public Safety Committee Minutes

The minutes were approved unanimously.

#### **3. NYPD Report** (\*See attached NYPD CompStat Report) –

Lieutenant Wolvers read the NYPD CompStat report. Issues discussed:

- CARE 311 Reform bill. NYPD responsiveness and accountability for 311 calls.
- Thefts of vehicle parts and grand larceny of automobiles: Conditions team specifically created to address auto theft, primarily working overnight doing enforcement, vehicle stops, responding to complaints and obtaining related video. Marked cars used to deter car thieves with visible police presence, unmarked cars also used. Several car theft crews operating in the area have been identified. 50<sup>th</sup> Precinct corresponds with Auto Crime Division that is actively investigating long term cases. 40.3% reduction in Grand Larcenies and 26.3% reduction in auto part theft in BXCB8 area, year-to-date.

- Student stabbed a few blocks from the John F. Kennedy Educational Campus. 3 arrests made, all juveniles.
- Abandoned car on Delafield Avenue next to the private parking lot of 5676 Riverdale Avenue. Car has flat tire, registration expired, parked at this location since September 2024.
- Illegal parking at 3862 Sedwick Avenue. Construction crew vehicles parked on sidewalk and in driveway. 50<sup>th</sup> Precinct stated they have addressed the issue with the developer and contractors.
- Car tire theft in front of 5282 Post Road. Various car break-ins and theft in this area during the last year.
- Stolen car parts from car parked on the service road at 4525 Henry Hudson Parkway.
- Large commercial vehicles parked along Broadway between the Van Cortlandt Motel and West 256<sup>th</sup> Street. Vehicles have been parked at this location for a long period of time. 50<sup>th</sup> Precinct stated it usually takes a long time for large vehicles to be towed due to limited heavy tow vehicles in the Traffic Enforcement Division and an overabundance of requests for large vehicles to be towed.
- Tires stolen from a car parked at 256<sup>th</sup> Street and Arlington Avenue.

Body camera upgrades with better batteries and higher resolution were discussed; deemed not a current priority by 50<sup>th</sup> Precinct.

Additional funding for youth programs was discussed. Law Enforcement Explorers program is a youth program that meets every Thursday. Necessity of funding presently unknown.

\*The Law Enforcement Explorers program provides young men and women from the city's diverse communities with an introduction to a career in law enforcement or a related field in the criminal justice system. The program, geared for ages 14 to 20, often results in strengthening ties between the community and police. Explorers are taught the importance of higher education, self-discipline, and respect for diversity and human dignity through training, involvement in community service projects, and other Exploring events.

Additional youth programs associated with NYPD are: NYPD Kids First, Summer Youth Police Academy, Police Athletic League, Options Program, Presentations and Mentoring.

Committee Chair will make further inquires into funding for youth programs and other resources requested by the Community Board that have previously been denied.

City agencies and City Councilmembers each allocate funds for various budget request items. A common agency response for previously requested budget items was "Agency does not support and cannot accommodate; remove request.", often blurring the line of where to request various budget items and the amount of funds necessary to obtain these items. Further research into the budgetary process as it pertains to Public Safety related requests is necessary. Past budgetary line items from funding agencies should be examined.

Public Safety Committee will complete prioritized capital and expense budget request lists for our next committee meeting on 4/15/25.

<u>Discussion of Bills A03133 & S03070: Amendment of the Penal Law in Relation to Unlawful Concealment of Identity</u>

The bills were originally discussed by the Public Safety Committee with NY State Assemblyman Jeffrey Dinowitz in September of 2024.

The assembly bill has since been revised, is in the NYS Assembly Committee on Codes and will potentially be voted on by the NYS Assembly.

Chair Green introduced a resolution of support for Bills A03133 & S03070:

## PUBLIC SAFETY COMMITTEE RESOLUTION SUPPORT FOR UNMASK HATE BILLS A03133 & S03070 March 18, 2025

WHEREAS, <u>State Assembly Bill A03133</u>, sponsored by Assemblyman Jeffrey Dinowitz, and <u>State Senate Bill S03070</u> sponsored by Senator James Skoufis, seek to amend the penal law in order to **reinstate** New York's mask ban to address the growing public safety threat from harassment and violence by individuals and groups using the cloak of anonymity against others **based on their race**, **religion**, **ethnicity**, **sexual orientation**, **or gender identity**.

**WHEREAS**, both bills establish the crime of **masked harassment** as a violation occurring "when a person wears a mask or other face covering that intentionally hides or conceals their face for the primary purpose of threatening violence against another person or placing another person or group of persons in reasonable fear for their physical safety."

**WHEREAS**, both bills establish the crime of **aggravated harassment** as a Class A misdemeanor "when while wearing a mask or face covering to intentionally conceal their identity and for the primary purpose of placing such person or group in reasonable fear for their physical safety, they strike, shove, kick, or otherwise subject another person to physical contact, including by removing religious clothing, article or headdress from such person."

**WHEREAS** this bill **EXEMPTS** individuals who are not wearing a mask or face covering for the primary purpose of menacing or threatening violence against another person but for reasons of health and medical concerns, religious purposes, protection against weather elements, holiday celebrations, costume events, occupational, trade, or professional safety.

**WHEREAS**, both bills are supported by the coalition Unmask Hate NY, the NAACP New York Conference, National Urban League, United Bodegas of America, the Anti-Defamation League, Jewish Relations Council of New York, UJA Federation of New York, Attorney General Letitia James, and Mayor Eric Adams.

**WHEREAS,** Bronx Community Board 8 notes in its report <u>Resources to Cope with and Combat Hate</u> published in June, 2024 by the Special Committee on Racial Equity the alarming increase in hate crimes targeted towards Jews, African Americans, Muslims, and LGBTQ Americans.

WHEREAS, New York State has had an anti-masked harassment law in place since the 1800's but repealed the law in 2020 to address the spread of COVID-19.

**WHEREAS** the previous anti-masking law was deemed constitutional after being challenged unsuccessfully by the Ku Klux Klan in the U.S. Court of Appeals in 2004 (American Knights of the KKK V. Kerik).

**WHEREAS** masking to conceal one's identity is not a constitutionally protected right, and these bills adhere to and uphold free speech protections and rights to assemble or hold demonstrations in accordance with the United States and New York constitutions.

**WHEREAS** NYS hate crimes have increased 69% since 2019 according to a report released August 28, 2024, by state Comptroller Tom DiNapoli who stated, "Fighting hatred requires our spiritual, political, community and business leaders to take active roles in denouncing hate, investing in prevention and protection efforts".

**WHEREAS** law enforcement agencies have stated that masking emboldens illegal activities such as hate crimes, assaults, and vandalism resulting in millions of dollars in damages, impedes investigations into criminal conduct, and hinders prosecutions of crimes.

WHEREAS, New York is experiencing a resurgence of masked harassment and intimidation, the Public Safety committee of Bronx Community Board 8 believes that anti-masked harassment laws can serve as an effective deterrent against such identity-based violence.

**THEREFORE, BE IT RESOLVED,** Bronx Community Board 8 strongly supports Assembly Bill A03133 and State Senate Bill S03070 and urges all New York State Assembly and Senate members and Governor Hochul to adopt them into New York State law.

The Committee voted on the resolution, which passed unanimously.
