Chair Ed Green called the meeting to order **at 7:05pm**

1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

2. Approval of the March 18th, 2025, Public Safety Committee Minutes

The minutes were approved unanimously.

3. NYPD Report (*See attached NYPD CompStat Report) –

Lieutenant Wolvers read the NYPD CompStat report. Issues discussed:

- Burglar responsible for 7 area burglaries was arrested. Perpetrator has been arrested multiple times for similar offenses and released almost immediately without having to serve prison time. Committee expressed concern about recidivist criminals being allowed to commit numerous crimes without facing harsher consequences.
- Superintendent of a building (undisclosed location) was arrested for grand larceny for illegally renting out apartments.

- Commercial vehicles parked North of Henry Hudson Parkway between 246th & 254th Street. NYPD has limited number of tow trucks available. Locations have been noted; tow trucks will be dispatched to remove the vehicles as soon as possible.
- On 4/14/25 4 tires were stolen off a car parked at 232nd Street & Henry Hudson Parkway by the nursing home.
- Committee inquired about hate crime statistics. 50th Precinct stated there have been no hate crimes reported.
- Resident reported cars are parking Illegally at fire hydrants by Riverdale Country Day School on a regular basis. Resident complained that multiple 311 calls were made but were determined unsubstantiated or resolved by NYPD. Resident disputes findings on 311 calls and stated some of the cars belong to school students.
- Resident complained about cars parked illegally, regularly blocking fire hydrants at 5400 Fieldston Road. 50th Precinct stated 2 summonses were issued at that location recently and they will send a Traffic Officer to the location in the morning and ticket any illegally parked vehicles they observe.
- Drug sales reported at 238th Street & Bailey Avenue. 50th Precinct aware of drug sales and have made several previous arrests at that location. 50th Precinct states the people involved are selling marijuana and NYPD will continue to monitor the area.

4. FDNY Report

No representative of FDNY was present. No report given.

FDNY has not been present at the Public Safety Committee meeting for the previous 3 months. Chair Green will reach out to FDNY to see what can be done about having an FDNY Representative available regularly for monthly meetings.

5. NYS Liquor Authority (SLA): Renewal Applications

Liquor, Wine, Beer & Cider

Bronx Alehouse located at 216 West 238th Street, applied to the Public Safety Committee to renew their liquor license for liquor, wine, beer and cider.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

6. NYS Liquor Authority (SLA): Alteration Applications

Tin Marin Bar & Lounge Inc., located at 3708 Riverdale Avenue, applied to the Public Safety Committee for an alteration to add to the adjacent premises.

Tin Marin Bar & Lounge Inc. intends to expand their business at 3708 Riverdale Avenue to the adjacent storefront at the same address.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

7. NYS Liquor Authority (SLA): Outdoor Dining Applications

Tin Marin Bar & Lounge Inc., located at 3708 Riverdale Avenue, applied to the Public Safety Committee for a sidewalk café to be added to their location.

It was noted that on November 21st, 2024, Bronx Community Board 8 passed a resolution recommending DOT approve a sidewalk café application by Tin Marin Bar & Lounge Inc. and that application was subsequently approved by DOT.

Committee questioned the owner about parking availability and the possibility of implementing valet parking for their customers.

The Public Safety Committee unanimously approved this application.

8. Old Business

Finalized Capital & Expense Budget Priorities 2027:

Capital Budget Request Items:

- 1) Argus Cameras: Captures continuous (24 hour) high-definition video footage, with a range of up to two blocks distance from the camera. The footage can be accessed by any 50th Precinct Police Officer and is often reviewed to identify perpetrators, license plates, and can also be a deterrent to crime (auto theft, local business security, etc.)

Locations:

- 1) West 238th Street & Broadway
- 2) West 238th Street & Bailey Avenue
- 3) Van Cortlandt Park South & Bailey Avenue
- 4) West 239th Street & Independence Avenue
- 5) West 261st Street & Riverdale Avenue
- 6) Fort Independent Street (facing 3353 Fort Independence Housing)

- 7) East side of Broadway between 5240 Broadway & 5360 Broadway
- 8) Allen Shandler Park entrance at 3545 Jerome Avenue
- 9) Reservoir Avenue & Webb Avenue
- 10) 2831 Exterior Street (facing Northbound)

Expense Budget Request Items:

- 1) John Deere Gator Utility Vehicle: Used for NYPD park patrol. Item patrols areas that are inaccessible to police cars. Especially useful for areas of Van Cortlandt Park (i.e. trails) where robberies and muggings have occurred. Increases police accessibility & visibility in remote areas of the park.
- 2) Five (5) Vehicle Anti-theft Boots for Vouchered Vehicles: Applied to the wheels of cars that have been seized by NYPD, preventing the cars from being moved.

9. New Business

Bob Bender stated that State and Assembly bills (S.4045A & A.2299A) were being discussed in Albany and the bills would address the problem of reckless drivers that have been ticketed repeatedly for various traffic infractions.

In 2023, a law expired, ending a city program that impounded vehicles of drivers with record of excessive recklessness.

Bills S.4045A & A.2299A would allow the installation of “speed limiters” on cars of repeat offenders.

An “Intelligence Speed Device” prevents the vehicle from traveling more than 5 miles over the speed limit.

S.4045A has 21 co-sponsors, and A.2299A has 18 co-sponsors. The bills would require placing an Intelligence Speed Device in the vehicle of any driver that accumulates 11 or more points on their license in a 24-month period or 6 or more speeding or red-light camera violations in a 12-month period.

Bob Bender introduced a resolution to the committee for consideration. The resolution proposes that the BXC8 Public Safety Committee support bills S.4045A & A.2299A.

There was consensus among committee members that bills S.4045A & A.2299A needed to be researched and discussed in greater detail before the committee could commit to support them.

This issue will be investigated further by the committee and the proposed resolution will be put on the next Public Safety Committee agenda in May for further discussion.
