Report from the Mayor's Office

The Mayor has taken actions to make the streets safer. He announced a city wide speed limit reduction to 15 miles per hour for all e-bikes and scooters.

The Mayor also signed an Executive Order and proposed legislation to codify into law the International Holocaust Remembrance Alliance's definition of antisemitism, addressing historic rise in anti-Jewish hatred.

Removed the barge that housed a jail in Hunts Point.

100,000 illegal vehicles have been taken off the street, 2,200 illegal firearms have been removed since the beginning of the year, and the NYPD Quality of Life division has been expanded to every precinct.

Year to date, down 15% in crime. Over the last 28-day period, down 21% in crime. Down 14% in robberies, 11% in felony assaults, 58% in burglaries, 30% in grand larcenies. Stolen vehicles were up 4% (23 last year vs. 24 this year). Water main break incident that occurred today in a construction site at Van Cortlandt South that caused the Major Deegan to be shut down. No update on the car jacking that was featured in the Riverdale Press. No foul play was involved regarding the deceased body found in the Jerome Park Reservoir in May.

BRONX COMMUNITY BOARD 8 – AGING COMMITTEE RESOLUTION SUPPORTING SENATE BILL S3607 & ASSEMBLY BILL A4639 JUNE 12, 2025

Bronx Community Board 8 Resolution to support the re-introduction and passage of New York State Senate Bill S3607 & Assembly Bill A4639 that prohibits public employers from diminishing health insurance benefits provided to Medicare-eligible retirees and their Medicare-eligible dependents or the contributions such employer makes for such health insurance coverage below the level of such benefits or contributions made on behalf of such retirees and dependents by the public employer as of December 31, 2021.

WHEREAS, so many constituents have served New York State and are now enjoying the retirement benefits they earned, and;

WHEREAS, the issue of healthcare is extremely important and must be protected for those retirees who have worked for their healthcare rights, and;

WHEREAS, this legislation preserves retirees' access to the level of health care they have received in the past, or being forced into a MAP (Medicare Advantage Plan) with limited medical providers and would also be at the MAP's whims for preauthorization decisions that may be based - at least in part - on Artificial Intelligence - instead of the medical decisions from their current regular medical providers, and;

WHEREAS, NYC Retirees have already testified in various forums, including at the January 11, 2023, NYC Council Civil Service and the Labor Committee public hearing, This violation of their earned healthcare benefits, which sets a harmful precedent for the rest of the State and Nation, and;

WHEREAS, the Bronx Community Board Aging Committee unanimously supported this resolution at its June 12, 2025, meeting.

NOW, THEREFORE, BE IT RESOLVED, Bronx Community Board 8 urges State Senators Gustavo Rivera and Robert Jackson; and State Assembly Members George Alvarez, Jeffrey Dinowitz and Manny De Los Santos; to exercise leadership by reintroducing and supporting Senate Bill S3607 & Assembly Bill A4639 in the upcoming legislative session.

WHEREAS, the New York State Department of Environmental Conservation (DEC) requested that the New York City Department of Environmental Protection (DEP) prepare a study known as the Use Attainability Analysis (UAA) in lieu of a comprehensive and long-term plan to control CSOs into our waterbodies -- namely the Van Cortlandt Park Hester and Piero Mill Pond, Harlem and Hudson Rivers; and,

WHEREAS, rather than protect primary contact recreation (PCR) as required by the Clean Water Act (CWA), the UAA recommends a reclassification to a standard whereby storms will limit swimming at least 30% of the 156 recreational season days. (See UAA page166); and,

WHEREAS, the UAA report makes the assumption that the selected project to protect PCR is too expensive, because it would lead to an increase in water rates and adversely impact low-income residents,

WHEREAS, there are countless adverse impact of "no action" by the agencies in protecting the waterbodies;¹ and,

WHEREAS, DEP has not yet provided sufficient GI projects outside of the Tibbetts Daylighting to mitigate CSOs into Harlem River² – despite various alternatives outlined in the 2019 GI Consent Decree³;

WHEREAS, the Committee has written testimony from the public that the unintended consequence of this proposal creates lack of access to places of worship; and

WHEREAS, the Committee heard testimony from the public that unintended consequences of this proposal are reduced access for seniors and people with disabilities using ambulettes and or access-a-ride to park; and

WHEREAS, the Committee heard testimony from the public that double parking is an issue on Bailey Avenue and eliminating a lane on both sides will increase the problem; and

WHEREAS, the Committee heard testimony from the public that if the DOT plan were implemented, it would cause a back-up of traffic for garbage collection and street cleaning; and

WHEREAS, the Committee heard testimony from the public that if the plan were implemented, the congestion and gridlock will cause emergency vehicles to be hindered in their vital functions; and

WHEREAS, the Committee heard testimony from the public that currently they spend hours searching for parking; and

WHEREAS, the Committee received written testimony from Health Care Workers that work near Bailey Avenue are negatively impacted by the lack of parking.

WHEREAS, the Committee does not approve the DOT plan as presented but finds that certain elements of the plan may be beneficial.

THEREFORE, BE IT RESOLVED, Bronx Community Board 8 does not approve the DOT plan as presented but finds that certain elements of the plan may be beneficial.

BE IT FURTHER RESOLVED, Bronx Community Board 8 appreciates the efforts of Mr. Perez and DOT members for bringing the safety issues on Bailey Ave. from Van Cortland Park South (VCPS) to West 225th Street; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends aggressive enforcement of double-parked vehicles on Bailey Avenue; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends that the DOT remove the Citi Bike station on the street located on Bailey Avenue & West 238th Street; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends NOT to install full concrete island at West 234th Street. In doing so it will not permit drivers traveling south on Bailey Avenue to make a left turn to travel north on Bailey Avenue; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 requests additional green options of trees and plants be placed in as many concrete plazas and areas where possible; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends that the DOT consider maintaining the two lanes (North and South Bound) and adding additional Stop signals for cars and bikes to decrease long-blocks; and

BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends DOT to consider evaluating the signage that states "No Standing or No Parking", in a half a mile radius to evaluate if it is needed to increase parking accessibility; and

BE IT FURTHER RESOLVED, it is recommended the DOT revert the flow of traffic along Albany Crescent to the former direction so that traffic flows SE from West 231ST Street to Bailey Avenue. Doing so will negate the need for a northbound left turning lane at the intersection of Albany Crescent and Bailey Avenue and ease congestion from vehicles exiting the Major Deegan Expressway on West 230th Street and traveling north along Bailey Avenue; and

LASTLY, BE IT FURTHER RESOLVED, Bronx Community Board 8 recommends that DOT initiate a study of alternatives for bike lanes along the Bailey Avenue corridor.

BRONX COMMUNITY BOARD 8 TRAFFIC AND TRANSPORTATION RESOLUTION CITI BIKE PROGRAM PHASE 3 EXPANSION RIVERDALE JUNE 25, 2025

WHEREAS, the New York City (NYC) Department of Transportation (DOT) recommended additional Citi Bikes on sidewalks and on the street in Bronx Community Board 8 (CB8) district; and

WHEREAS, the presentation by NYC DOT Citi Bike Program at the Traffic and Transportation

(T & T) committee on May 15, 2025, outlined a total of 22 new stations; and

WHEREAS, the plan will eliminate 22 parking spots in CB8 residential areas; and

WHEREAS, the T & T Committee heard testimony from the public that the Citi Bikes on the roadbed will be impacted on their quality of life and inability to access businesses; and

WHEREAS, the T & T Committee has written testimony stating there are five Citi_Bike locations on Broadway between West 261st Street and West 251st Street. This is excessive for one densely residential stretch that is clearly a "parking desert." The area between W.

254th St. and Lakeview Ave. has already lost approximately 18 parking spots as a result of the 2018 Broadway re-design; and

WHEREAS, the T & T Committee heard testimony from the public that cyclists ride on the sidewalk and make it unsafe for pedestrians; and

WHEREAS, the T & T Committee has written testimony, that adding Citi Bike beds on Kappock Street and Independence Avenue and on Kappock Street at Knoll's Crescent on the roadbed will cause double parking and safety concerns.

THEREFORE, BE IT RESOLVED, Bronx Community Board 8 Board Members (Board) finds that certain elements of the plan may be beneficial to CB8; and

BE IT FURTHER RESOLVED, other elements of the plan create unnecessary hardship for residents due to the loss of already scarce parking, while also missing opportunities for more efficient siting.

The board recommends the following for consideration:

1. Netherland Avenue & West 232nd Street (East roadbed - Daylit):

This location will remove valuable residential parking in an area with limited curbside space and no alternative parking options. The Board encourages DOT to explore nearby off-street or sidewalk locations that accommodate a dock without sacrificing parking.

2. Henry Hudson Parkway East & West 231st Street (Off-street along parkway):

While the Board supports the use of off-street space, the DOT must ensure that this placement does not interfere with park access, pedestrian safety, or emergency vehicle routes.

3. West 231st Street & Tibbett Avenue (South sidewalk):

Sidewalk siting here is appropriate if pedestrian access and American Disabilities Act (ADA) compliance are preserved. In general, sidewalk locations like this minimize disruption while maintaining accessibility.

4. Kappock Street & Independence Avenue (South roadbed):

Given the steep grade, traffic volume, and bus activity along Kappock Street, the Board strongly recommend that DOT explore sidewalk or off-street alternatives. Roadbed installations here could create dangerous conflicts for both cyclists and drivers.

5. Knolls Crescent & Kappock Street (East roadbed):

Knolls Crescent has wide sidewalks and ample off-street options to better serve Citi Bike users without further reducing residential parking.

6. Johnson Avenue & West 235th Street: The sidewalk location seems reasonable provided ADA compliance is maintained.

7. **West 238th Street & Riverdale Avenue:** This location would eliminate parking in a busy commercial-residential area. Nearby sidewalks or off-street options North of the commercial corridor may better serve both riders and the community.

BE IT FURTHER RESOLVED, the Board appreciates the efforts of the Citi_Bike Program in allowing the community and Bronx CB8 in the site selection; and

BE IT FURTHER RESOLVED, the Board recommends aggressive collection of data in Citi Bikes being used; and

BE IT FURTHER RESOLVED, the Board_recommends the sidewalks on Riverdale Ave. are in many places wider than sidewalks in other commercial areas within the already approved list. The Board's recommendation is to replace Riverdale Ave. & W. 263rdSt., W. 261st, W. 258th, and W. 254th St. with nearby locations on sidewalks, which are plentiful. Possible locations include the Riverdale Post office, 5951 Riverdale Avenue, 6118/6114 Riverdale Avenue, and 5676 Riverdale Avenue; and

BE IT FURTHER RESOLVED, the Board also recommends location at the Riverdale Metro_North Railroad Sation on Palisade Avenue; and

BE IT FURTHER RESOLVED, the Board recommends location of Palisade Avenue at Independence Avenue at the top of Bradely Terrace staircase leading to the Spuyten Duyvil Metro-North Railroad Station; and

BE IT FURTHER RESOLVED, the Board recommends a location at the Spuyten Duyvil Metro-North Railroad Station; and

BE IT FURTHER RESOLVED, the Board recommends location of West-231st Street and Broadway; and

BE IT FURTHER RESOLVED, the Board is requesting data on the usage of the following Citi Bike locations for years 2024-2025:

- 1. Giles Place and Fort Independence
- 2. Kingsbridge Terrace and West 230th Street
- 3. Sedgwick Avenue and Giles Place
- 4. Tibbet Avenue & West 234th Street
- 5. Naples Terrace and Broadway
- 6. Irwin Avenue and West 232nd Street

LASTLY, BE IT FURTHER RESOLVED, the Board requests DOT to contact Bronx Community Board 8 at least thirty (30) days prior to the implementation of any new changes in this proposal.
