Chair Ed Green called the meeting to order at **7:00pm**

1. Introduction of Committee Members and Guests

Roll Call of Committee Members. Committee members introduced themselves.

2. Approval of the December 16th, 2025, Public Safety Committee Minutes

The December 16th Public Safety Committee minutes were approved unanimously.

3. NYPD Report (*See attached NYPD CompStat Report, Quality of Life Team Report, Traffic Report) –

Captain Oktrova, newly appointed Commanding Officer of the 50th Precinct introduced himself and read the NYPD CompStat report. Issues discussed:

- 50th Precinct is posting more advanced statistics on their website.
- Precinct will have a police car patrolling up and down Broadway on all tours.
- Grab-and-go robberies at C-Town (5686 Mosholu Avenue) by youths. Employee of store punched in the face. Twelve incidents have occurred since summertime. Twelve, five and two youths involved in separate incidents. Crimes typically occur around 5pm. 50th Precinct Q-Team will consult Store Manager.

- Burglary at Wing Stop restaurant (5625 Broadway)
- Resident reported three DOA's (Dead on Arrival) bodies recovered in unspecified building Claflin Avenue. 50th Precinct stated they have not received any reports of this and if the fatalities were drug related or of a suspicious nature they would have received notification.
- Two residents reported drugs and prostitution occurring in and around a homeless shelter at 2788 Claflin Avenue. Multiple homeless shelters reported in the area. 50th Precinct and Public Safety Committee have no knowledge of any homeless shelters at that location or vicinity. Further investigation will be undertaken.
- Multiple burglaries in apartments in Greystone Avenue buildings. Perpetrator used fire escapes and back access to buildings for entry. 50th Precinct stated they are investigating and have a suspect that is a homeless person known to the precinct.
- Resident complaint of ongoing vehicle break-ins. Broken windows and stolen air bags, rims, tires and mirrors on Goulden Avenue, Reservoir Avenue, Sedgwick Avenue and 195th Street near P.S. 340. Resident reports these crimes have been occurring since the summertime. 50th Precinct will investigate. NYPD Aviation Unit and Bronx Auto Larceny Unit are available options to catch perpetrators and prevent further incidents.
- Resident complaint of large trailers and other vehicles abandoned for up to four months on Johnson Avenue, uphill towards Kappock Street. Many vehicles have expired registrations, fraudulent license plates flat tires, darkly tinted windows. 311 calls documented. 50th Precinct is aware, submits weekly lists for towing and are waiting for tow truck availability.
- Broadway merchant request for more traffic tickets to be issued to cars parking in bus lane along the Broadway corridor between 230th Street and 225th Street.
- Resident concerns about Exotics smoke shop at 5586 Broadway possibly selling cannabis illegally. Public Safety Committee unanimously agreed that a letter should be sent to the Sheriff's Department requesting an investigation.
- Fenwick's at 432 West 238th Street was closed, padlocked and multiple arrests were made after a police investigation discovered the business was selling liquor without a liquor license. Resident complaints to Bronx Community Board 8, Assemblyman Dinowitz's office and 311 reports were instrumental in the investigation and closure of the establishment. The Public Safety Committee agreed that because of the closure there was no longer a need for the committee to write a letter to the Office of City Night Life about Fenwick's.

4. FDNY Report

Battalion Chief Donnelly had to leave the meeting early because of a smoke emergency at an undisclosed location. The FDNY statistical report was given to the committee and read by Community Committee Member Michael Courtney. Issues discussed:

- Fire at Noir nightclub on 3638 Bailey Avenue. Under investigation by Fire Marshals. Noir applied for a State Liquor Authority license in October 2025, and Bronx Community Board 8 passed a resolution recommending disapproval of their SLA application (largely due to the owners not agreeing to sign a 2am closing agreement). In November 2025, SLA informed Committee Chair Green that the agency had not received an application from Noir. The 50th Precinct and Public Safety Committee have no knowledge of this establishment ever being open for business. Public Safety Committee will continue to monitor and ask for an update from SLA on application status.
- Resident stated the cap on the fire hydrant in front of 2799 Claflin Avenue needs to be replaced. Request will be relayed to FDNY through Bronx Community Board 8.
- Report from the District Service Cabinet meeting stated FDNY was having difficulty on Bailey Avenue due to recent DOT bike lane installation and road lane reductions. Captain of the Bailey Avenue Fire

Unit voiced his frustration navigating traffic. Two accidents have been reported since DOT implemented bike lane and road reductions.

5. NYS Liquor Authority (SLA): Renewal Applications

Liquor, Wine, Beer & Cider

The Johnson Diner & Bar located at 3533 Johnson Ave, applied to the Public Safety Committee to renew their liquor license for liquor, wine, beer & cider.

Representatives of NYPD's 50th Precinct stated they were unaware of any prior significant disturbances or complaints at the location of this establishment.

The Public Safety Committee unanimously approved this application.

Tin Marin Bar & Lounge, located at 3708 Riverdale Ave, applied to the Public Safety Committee to renew their liquor license for liquor, wine, beer & cider.

The Public Safety Committee unanimously approved this application.

Wine, Beer & Cider

Urbano Estevez, a representative of Mon Amor Coffee & Wine, located at 234 West 238th Street, applied to the Public Safety Committee to renew their liquor license for wine, beer & cider.

The Public Safety Committee unanimously approved this application.

The applicant signed a 2AM closing agreement for the first year of operation.

The Public Safety Committee unanimously approved this application.

7. Old Business

Update: 311 Reporting and Community Engagement:

The 50th Precinct stated a high volume of 311 reports is the most effective way of bringing attention to and resolving most quality-of-life crimes in our area.

The Public Safety Committee will work with Bronx Community Board 8 Staff to enhance social media platforms and increase visibility of 311 information.

The BXCB8 website currently has a link to 311, but people need to scroll down near the bottom of the homepage to view and access it (along with various other links). One small 311 link at the bottom of the BXCB8 webpage with no explanation attached is insufficient for raising awareness of the importance of residents making 311 reports.

The committee will write a short statement detailing “how to report complaints”, listing several examples like excessive noise, abandoned vehicles, etc. It will also provide basic information about the simplicity and effectiveness of using the 311 system and the importance of reporting incidents via 311. The statement will be considered for the Bronx Community Board 8 website and social media platforms.

Flyers with 311 information will be created and made available at Board events and area locations when appropriate.

NYC Councilman Dinowitz sponsored “CARE311”, which is 311 reform legislation aimed at enhancing the 311 service system in New York City. The committee will consult Councilman Dinowitz’s office about ways to increase community awareness about 311.

Update: Office of Cannabis Management (OCM) Applicant Questionnaire and Interviewing Process:

Public Safety Committee members reviewed both drafts of documents presented at last month’s meeting.

The committee was satisfied that no major changes were necessary but there is flexibility for new questions to be added to the interviewing process when appropriate.

Bronx Community Board 8 Staff will send the questionnaire to OCM applicants whenever the Board receives an OCM application. Applicants will be required to return the completed questionnaire to the Board at least one week prior to the Public Safety Committee meeting.

8. New Business

Discussion: Special Committee on Racial Equity (SCRE) Recommendations for the Public Safety Committee:

Committee will incorporate abandoned vehicles and removal into monthly reporting at committee meetings and follow up on recurring areas.

Committee will monitor and follow up on 311 & 911 calls from area merchants and collaborate with the BXCB8 Economic Development Committee on all public safety related merchant complaints.

Committee will report community complaints to NYPD Q-Teams monthly. Q-team representatives will be added to Board correspondence with the 50th Precinct on 311/911 related issues.

FY28 Budget Priority Requests:

50th Precinct was asked to provide a list of all needed budgetary items for FY28, including new Argus cameras.

The committee requested an updated list of all Argus cameras in the 50th Precinct area.

Committee members were asked to present any public safety related budgetary items they think are relevant at the February Public Safety Committee meeting.
