Guest Speaker: Council Member Susan Zhuang, Chair of Committee on Aging, NYC Council:

Budget hearings will be held in March. She is anxious to hear from us what our needs are concerning capital funding. Which OACs need updating. She noted several other priorities.

- Food insecurity and in particular HRA should keep track of stolen food stamps

and provide information on alternatives.

- Affordable housing for older people.
- Increased access to iPads and training to enhance social connection

Aubrey Balcolm inquired as to the best way to advocate for more neighborhood and community-based NORCs.

Council Member Zhuang suggested testifying at hearings and writing letters to different Council Members. She requested a Google Contact list of Committee members so she could forward information. Jaylyn will take care of this. Eric Dinowitz's office should have information on zoom links for hearings.
