- b. Shooting arrest at 231st and Kingsbridge Ave. the person was in a gang, but the shooting was not gang-related.
- c. Last month crime was up. This was due to an increase in property crime.
- d. Felony assaults were up, included 2 shootings. Both were gang related and arrest were made in both.
- e. Burglaries are down.
- f. Car break-ins continue to be an issue. 1/3 of the grand larcenies are auto related incidents. This area is a magnet for car break-ins because people here have nice cars and money. An individual who was breaking into cars was arrested. Since this individual was apprehended, there have been only 2 break-ins in 2 weeks.

- g. Robberies are up because perpetrators are threatening security people in the stores.
- h. Under new sentencing guideline, judges are required to release.
- i. The 50th Precinct has 5 new officers.

Ms Donato noted noise complaints on Cannon Place They are now coming from inside the park. People are partying in the triangle on Fridays and the weekend. People need to call 311. Most of the noise is coming from Fort Independence, not Cannon Place.

Resident asked about drug sales in precinct. Captain Melendez said the 50th Precinct area is a stash area, not a sales area.

Parilla Restaurant continues to cause problems. There was a double slashing there on Saturday night. We will investigate what type of liquor license they hold, as well as other permits at that location. The 50th is building an action against the club.

Resident spoke about 239th to 235th and Hudson Manor Terrace. Speeding along that stretch. She additionally spoke about double triple parking by MS141. This occurs mostly between 7:30 and 8am and at 2:30. Captain Melendez stated that he will contact traffic agents.

Mr. Hammerman said that cars are blocking the garage, so people cannot get out of garage. Again, Captain Melendez stated he will send someone out, but he cannot provide constant surveillance

The presence of a food truck on Johnson Ave was noted. Captain Melendez noted that they are compliant, they have a permit. As long as they have customers they are going to stay there.

- 6. SLA New Applications
 - a. Ember, 5693 Riverdale Ave. Primarily an upscale Kosher restaurant. The Principal, Michael Kelly did not appear. No vote was taken.
