3. Police Report presented by Community Affairs Officer Ralph Cintron

Played a video about scams

Committee member Ed Green asked about scams – identity theft, check duplicating. Asked if this is common.

Officer Cintron said these thieves alter checks. He said there are pens that cannot be washed off a check. Pens can be purchased at Staples. These are "Uniball 207"

Scammers get info from social media. Make sure you check your privacy settings. Committee member Jyll Townes asked about a burglary on Netherland Ave. Officer Cintron gave info about a Nov. 10 incident where the resident was home. There was no camera to record the incident.

Ed commented about homeless at 242nd St. Melendez got them out, but they are back. Officer Cintron said they do sweeps. Latest location was near Yonkers. District 3 is responsible for the trains.

4. Fire Report presented by Chris Bearch

Holiday inspections start on the weekend after Thanksgiving. FDNY does commercial inspections and common areas of residential buildings.

There was a fire on 240th St first week of November.

5. CERT (Community Emergency Response Team) presentation

a. Gave overview of CERT

10 week training: Fire safety, search and rescue, terrorism response. Anyone can join CERT

"Go Bags"

Everyone in the family should have a Go Bag, including pets. Information was distributed including a book that lists everything that should be in the bag. Make sure to have copies of important documents: passport, birth certificate, medical info, a week's worth of medications, whistle or bell. Keep documents in a waterproof container. It's all about grab and go. Keep the bag in an accessible area.

Last call is 1:00 a.m. and they will close at 2:00 a.m. From 1 to 2 will be to clean up.

They expect events to be held mostly on Thursdays, Fridays and Saturdays. Max capacity is 74

Non-amplified music

Clientele by word of mouth, family owned.

Bartender is included in their event package. They have their own, on-site licensed bartender, no bartenders from outside the establishment will be allowed to serve. Lt. Hines stated he has reservations about this establishment.

When this place came before the committee last month, Captain Melendez said he had reservations. Committee member Ed Green suggested we vote contingent upon what we hear from Captain Melendez.
