o Coronavirus Updates:



As you are aware, the City is currently responding to the novel coronavirus, and we want to make sure that you are provided with the most up-to-date information.

New York City is asking residents to call 911 in a true emergency and only visit emergency rooms if you are severely ill. Our first responders are being inundated with patients. If you are experiencing symptoms, please call 311. For additional information and updates, visit the Department of Health's website.

Please remember to stay home and social distance if you are able to. Washing your hands for at least 20 seconds with soap and water or alcohol based sanitizer. Cover your nose and mouth with a tissue or flexed elbow. Avoid contact with others, especially those who are unwell.

Transportation:

The MTA has reduced service by at least 25%. You can find the full rundown of service changes here. Alternate Side Parking has been suspended on a week by week basis. Please **click here** for more up to date information.

Housing:

If you or somebody you know are facing eviction please know that Eviction Orders have been suspended statewide indefinitely. This means that during this health crisis, landlords can't sue, there will be no evictions, and all courts that hear eviction cases are closed. The moratorium applies to both residential tenants (in all types of housing) and commercial tenants. The Right to Counsel NYC Coalition has made an FAQ section available on their **website** to address questions about the eviction moratorium. Homelessness Prevention: The Partnership for the Homeless prevents people from experiencing homelessness by helping them avert crisis and focus on long-term stability. They provide a range of services including eviction prevention, housing support, financial assistance, legal assistance/referral, landlord/tenant mediation, housing subsidies assistance/referrals, and income support & benefits. During the coronavirus emergency response, they continue to serve current and new clients. One-on-one and group meetings will be held virtually. <u>New York Public Library:</u> All Public Libraries have been temporarily closed, but they are offering great programs and resources. <u>Parks:</u> At this time, New York City parks are open. Due to overcrowding, several playgrounds have been closed. While solo exercise is okay, team sports (such as basketball, football, softball, and soccer) are not permitted in our parks at this time. You might notice that the Parks Department has removed basketball nets and tennis nets. If choose to visit one of our local parks, please continue to practice social distancing and maintain a 6 ft distance with other park-goers. Park facilities are being cleaned and disinfected daily. <u>Local Senior Centers:</u> Local senior centers have been temporarily closed, but staff is working hard to serve our aging community. Meals are being delivered to seniors in need by the Department of Aging. Phone call check ins are also being made by our local senior centers. 
