Chairman Fanuzzi called the meeting to order at 7:30 PM.

1. Gallery Session

- A. Paul Elston, representing Friends of the Hudson River Greenway, advised of their support for the resolution that will be presented at this meeting from the BXCB8's joint resolution of the Parks & Recreation and Traffic & Transportation Committees. They believe the resolution properly reflects strong community support for waterfront access and concerns expressed regarding the routes to the greenway. He stated that the Hudson River Greenway plan presented is only conceptual. The next step should be to engineer a waterfront route and to determine cost and benefits of alternative waterfront design, including possibility of burying overhead power lines; and also consider removing Metro-North track No. 6 to allow space for the greenway. He advised that a meeting held in 2011 with the MTA President with Friends of the Hudson River Greenway, elected officials, and NYMTC to discuss locating the greenway on the waterfront, the MTA President agreed to evaluate for feasibility and cost. A written report was issued determining the feasibility to build the greenway west of the tracks on Metro North right-of-way between sections of Riverdale Metro-North Station and Yonkers at a cost of \$15 million. He urged the Community Board, elected officials and Charles Moerdler, MTA board member to support the waterfront greenway design.
- B. Sylvia Cox, Office of Child Support Enforcement, discussed services provided which includes DNA testing for unmarried parents, program for low income dads to reduce/modify payments, and more. Flyers were left on table.
- C. Yael Levy announced Riverdale Riverfest 2014 5th Annual event being held on June 15th from noon to 6:00pm at grounds of the College of Mount Saint Vincent, Riverdale Avenue at West 263rd Street. There will be food, boat rides, live music, and exhibits. Admission is free. She encouraged sign-up of volunteers. Contributions are welcomed and are tax deductible. Flyers were left on table. The website is www.RiverdaleRiverFest.org.

- D. Joyce Smith, Mayor's Office to Combat Domestic Violence, advised about the recently opened City-wide Family Justice Centers (FJC) which provides services to victims of domestic violence. The Bronx FJC is located at 198 East 161st Street. FJC's are safe, caring environments that provide one-stop services and support. She noted that the Bronx has a disproportionate amount of domestic violence. FJC partners with over 40 agencies, services are free and all are welcome regardless of language, income, or immigration status. Literature was left on the table.
- E. Frank Anelante, Riverdale/Spuyten Duyvil Coalition, referred to the resolution that will be presented later in the meeting concerning the Henry Hudson Greenway link. He advised that the Coalition agrees with the water route proposed in the resolution and discussed certain points of rejection with the plan that was agreed upon with the committees but is not in the resolution. He stated that to avoid ambiguity, those concerns should be included in the "Be It Resolved" clause, and it should also be stated that the NYMTC plan with certain objections is rejected. Mr. Anelante also stated the issue related to widening the cyclists/pedestrian pathway over the Henry Hudson Bridge was not in the NYMTC plan, and should be explored with the Traffic & Transportation Committee working along with MTA to determine feasibility.
- 2. Approval of Board Meeting Minutes of March 11, 2014
 - R. Press referred to page 2, Public Hearing on the report and comments on responses from the City Agencies on the Capital/Expense Budget Priorities for FY 2015. He requested that the following statement made by him be added when the floor was opened for discussion: R. Press expressed disappointment with the rejection of the safety problems at PS 7 with the inner and outer doors, especially after recent incidents. He also expressed that a low number budget item may be approved.

The amended minutes were approved by a vote of 39 in favor, 0 opposed and 1 abstention (S. Froot)

3. Discussion of Executive Committee Meeting Minutes of April 2, 2014

The minutes will be reviewed by the Executive Committee at its next meeting.

4. Chairman welcomed Deputy Inspector Paul Rasa and invited him to address the Board.

Deputy Inspector Rasa reviewed the year to date stats and discussed crime in the 50th Precinct: rapes 5, robberies 32 vs 22, burglaries 32 vs 32, grand larceny 78 vs 100, grand larceny auto 29 vs 16, transit 6 vs 3, housing 13 vs 9 (increase due to domestic assault). Noise complaints last year were 600; 26 summonses issued this year; 22 DWI arrests.

Chairman inquired about the incident involving the racist message written on the vehicle of a neighborhood resident while parked in the area of the White Hall building. The Deputy Inspector informed that this is being treated as a hate crime and has not been resolved yet.

5. Chairman welcomed Assemblyman Jeffrey Dinowitz, congratulated him on his 20th year legislative milestone and invited him to address the Board. Assemblyman Dinowitz reported on the status of mail complaints with 10463 zip code. His office and the offices

of his colleagues had been deluged with complaints of non-delivery of mail. The Assemblyman along with Congressman Engel, Senator Klein, and Councilman Cohen met with the Bronx Acting Post Master. The station manager was removed and there has not been a replacement yet. However, service has improved; He announced that a hurried push to make the State's Budget deadline by Senator Klein in the Senate and by himself in the Assembly was successful getting through a budget line bill that has impact on certain construction projects where the building's square footage is above 30,000 and above three stories to undergo a rigorous review process. Such applications will now be subjected to review by State Health Commissioner, State Education Commissioner and local community board. This new law will cover the Montefiore project proposed for Riverdale Avenue. New SCRIE income guidelines have been elevated from \$29,000 to \$50,000 allowing the rent of seniors 62+ to be frozen at 1/3 of their income.

6. Chairman Fanuzzi welcomed NYC Comptroller Scott Stringer and invited him to speak.

Comptroller Stringer expressed his pleasure for having the opportunity to visit the Board as he marks 100 days in office. He reported on the various responsibilities of the Comptroller and ways he is looking to save the City money and cut down on fraud and waste. City contracts are being reviewed. He noted the absence of any issuance of Comptroller directives since 2005. He has activated that power and has issued a directive calling for all IT contracts to submit time sheets for workers; and in the case of hiring consultants, a resume must be attached. He is actively looking at City agencies and money saving measures. The Comptroller's office has issued a first time report documenting the number of certified arts teachers in the City's public school system. 28% of public schools have no certified arts teachers, in the Bronx the number is 33%, in the South Bronx it is 42%, in Central Brooklyn 42%. Comptroller Stringer will look to the Board to contact his office for audits. He thanked the Board for its service and promised to return for future visits.

7. Chairman Fanuzzi invited Councilman Fernando Cabrera to address the Board.

Councilman Cabrera reported: police security cameras are up in NYCHA's Marble Hill and Fort Independence Houses and crime has decreased. He is working with Congress to allocate funding for technology labs that teach programming to middle-school and high school students; sponsoring All Family Legal Clinics regarding issues with child support, domestic violence, and immigration twice weekly; and the Department of Environmental Protection will be required to notify parents of any environmental problems at schools. He thanked the Board for its service.

8. Chairman Fanuzzi invited Councilman Andrew Cohen to address the Board.

Councilman Cohen reported that he has been in attendance at several Board meetings, including Land Use and various other committee meetings. He reiterated that his office is open at 3636 Waldo Avenue and he is available.

9. Presentation of the Comeback Kid Certificate of Recognition

Chairman Fanuzzi called upon the members of the Youth Committee, chair L. Parker, and committee members R. Pochter-Lowe and A. Fella to make the presentation of the Comeback Kid Certificate of Recognition.

It was announced that Bronx Community Board No. 8's Youth Committee established the Comeback Kid Certificate of Recognition to acknowledge students in community centers that have overcome challenges and demonstrated improvement over a period of time. It is the Committee's belief that by recognizing student participants in community centers, it can reward those youth who are working hard to improve their future and are deserving of recognition and support. Recipients must be nominated by a community center in the Bronx Community Board No. 8 area.

Bianca Perez received the 2014 Comeback Kid Certificate of Recognition and came forward for the acknowledgement.

Ms. Perez was nominated by the Kingsbridge Heights Community Center (KHCC). She is a high school sophomore at Mott Haven Village Preparatory School. Through hard work and effort, Ms. Perez completed her homework assignments, sought assistance when needed from teachers at school and the staff at the KHCC Teen Center. To be a Comeback Kid is to be resilient and strong in the face of adversity and Bianca Perez encompasses all these traits.

Bianca Perez was presented with Community Board No. 8's Comeback Kid Certificate of Recognition with the following inscription:

"Bronx Community Board No. 8 honors you for overcoming challenges and for working hard to improve your future."

She received all around congratulations on a job well done.

- 10. Report from the Office of the Bronx Borough President J. DeSio
 - Community Board members who have submitted a reappointment application should continue to serve until they receive a letter from the Borough President regarding their reappointment. The terms of community board members who have chosen not to reapply for a new term ended on March 31st.
 - Bronx Borough President Ruben Diaz, Jr. praised the decision of the NYS Supreme Court Appellate Court in the matter of the South Bronx Unite, et al v. NYC Industrial Development Agency, et al, concerning the future of relocation of FreshDirect to the Harlem River Yards in Mott Haven. The project is allowed to move forward. The court found that the decision of the lower court to dismiss the lawsuit in May 2013 was correct, and that the City did not violate the law in its environmental review process.

11. Chairman's Report

- Chairman Fanuzzi referred the Board to the Executive Committee minutes for a full report.
- Chairman reported that the following Board members have either resigned from the Board or have not re-applied for membership: Patricia Mullen, Thailary Lim, Pedro

- Reyes, Diane Kirksey-Floyd, and Ari Spett. Chairman expressed his gratitude for their service.
- A response letter was received from Van Cortlandt Park Ice Rink regarding the abrupt season closing and impacting the Youth Committees planned annual Ice Skate Day hosting of 100 youths from local community centers event. The letter cited that the closing was due to softening ice condition. To make up the loss, an offer has been extended to the youth groups to attend a skate event at the World Ice Arena in Flushing within the next six months for spring or summer ice skating.

12. Election of the Nominating Committee

- Chairman stated that the election of the Nominating Committee would go forth in accordance with the Bylaws, Article V, Section 2 of the Board's Bylaws. Chairman summarized and read aloud the rules and guidelines governing the Nominating Committee. From the Bylaws: at the Board meeting held in April, a nominating committee consisting of not less than three (3) nor more than five (5) Appointed Members shall be elected by the Board. This committee shall designate its chairperson and present candidates for the offices to be filled at the election meeting. Additional candidates may be nominated from the floor at the election meeting. From the
- From the Ethical Guidance manual: In addition to the Bylaws, which specify the structure and duties of the committee, the following procedures are to be followed pursuant to resolutions adopted by the community board on February 14, 2012 and November 13, 2012. Officers: A member of the nominating committee may not be nominated by the committee for a position of officer; Committee Chairs: A member of the Nominating Committee under consideration for a committee chair shall recuse him/herself from discussion and vote for that position; In the event of a tie vote in the Nominating Committee, both candidates shall be presented to the Board; The Nominating Committee must complete its activities and present its slates at least two calendar weeks before the June meeting at which the election will take place; When the nominating committee is elected, there will be a statement that all officer and chair positions are to be considered open and available for nominations; Within five (5) business days of the formation of the nominating committee, each current chair or officer shall notify such committee of his or her intention not to be considered for renomination. The nominating committee will then notify all board members of such position(s) within 24 hours of such notification.
- In addition, the Chair read a statement of policy and principle to be read to the Board before each nominating committee election. Board Members who are putting together a proposed slate, should make their choice, bearing in mind that it is both good policy as well as conducive to the smooth functioning of the Board to strive for a Nominating Committee and a slate of proposed Officers and Committee Chairs who represent diverse geographic acres within the Board, diverse communities, diverse ethnic and racial groups, and diverse professional and work backgrounds. The choices made should also consider the experience of any nominee as a Board Member and the extent of the interest shown by any such nominee in participating in Board matters. These factors, while not meant to impel any particular individual choice, should always serve as general guidance.

Chairman opened the floor for nominations.

C. Economic Development – S. Villaverde

The Committee is planning for a Job Fair. May 9th is the tentative date, at Kingsbridge Library. They will link with the Library's English as 2nd Language program. S. Villaverde thanked M. Khury and P. Ellis for their work in facilitating the Job Fair.

D. Education – S. Alexander

- 1. A letter was sent to each school principal requesting their participation with budget items submissions for Fiscal Year 2016. Two responses were received so far. S. Alexander is hoping for a groundswell of schools participating this year.
- 2. Discussed Fiscal Year 2015 budget response regarding non-funding for replacement and repair of doors at PS 7.
- 3. S. Alexander advised about a Rally for School Door Alarms being held on April 10th, at City Council, led by Councilmember Robert Cornegy, Jr. for support of his bill to equip the doors of public elementary and special education schools with audible alarms. To that end, she would look forward to the outer doors at PS 7 being alarmed. She discussed the urgency for getting the funding in place for PS 7 doors during this year's budget process and made an appeal to the Chairman, District Manager, Elected Officials, and all others to advocate for this funding for children safety.

- 6. The next meeting will be held on May 27th.
- 7. Councilman Cohen informed that he is a co-sponsor of the School Door Alarm bill. He will look into the budget request for the doors at PS 7.

E. Environment and Sanitation - S. Marquez

- 1. The Committee will not meet in April due to the holiday.

- 3. Thanked Councilman Rodriguez and his aide Tony Edwards for the playstreet initiative.

F. Health, Hospitals & Social Services – S. Froot

- Presented a resolution for Kingsbridge Heights Community Center's Play Street.
 - M. Khury offered a friendly amendment as agreed by the Executive Committee, a statement to reflect that the event was previously held. The amendment was accepted.

Chairman called for a vote on the following amended resolution:

WHEREAS, the ongoing obesity epidemic has caused a high percentage of children to experience diminished capacities and medical conditions not widely known to teens and children; and

WHEREAS, Children residing in the Bronx are particularly at risk due to poor diet and a lack of exercise opportunities, and have the highest rate of obesity in the city; and

WHEREAS, The NYC Department of Health and Mental Health, along with the NYC Departments of Parks and Transportation, have created a program called Play Streets to help combat childhood obesity in our city; and

WHEREAS, The Play Streets initiative is designed to allow communities to open up their streets to pedestrians for play on a recurrent basis. They occur on local streets officially closed to traffic, and are open to people at regularly scheduled times; and

WHEREAS, Kingsbridge Heights Community Center (KHCC), with the support of Bronx Health REACH and Bon Secour New York Health System, have applied for a specific area designation. These groups will supply funding and administrative support for games, equipment, workshops and promotion of healthy eating; and

WHEREAS, A Play Street is to be created in front of KHCC on Kingsbridge Terrace, between Perot Street and Summit Place on Fridays, from 10:00 AM to 2:00 PM in July and August 2014, coinciding with KHCC's on-site farmers' youthmarket; and

WHEREAS, this event was previously held;

NOW, THEREFORE BE IT RESOLVED, Bronx Community Board No. 8 fully supports and endorses the application of the Kingsbridge Heights Community Center to create a Play Street as designated above, during the summer months of 2014.

The meeting will include a Public Hearing on the notice received from Luther Social Services of New York (LSSNY) regarding their plans for a transitional group home for Unaccompanied Minors, at 2865 Kingsbridge Terrace. LSSNY is under contract with the federal Office of Refugee Resettlement to provide foster care and shelter for Unaccompanied Minors who have entered the US without authorized immigration status. The Board had received this same notice from LSSNY a year ago for the same location. However funding fell through. WHEREAS, residents of Community Board 8 support a riverfront Hudson River Greenway extending from Spuyten Duyvil to Yonkers, providing runners, walkers, cyclists, people with disabilities, and others a superb view of the Palisades and access to the Greenway to the north and to the south that establishes continuous Greenway access between Manhattan and Westchester; and have advocated locating the Greenway route along the Hudson River in the 1998 report of the Bronx Advisory Committee to the Hudson River Valley Greenway;

WHEREAS, the New York Metropolitan Transportation Council (NYMTC), with funding provided in part by Senator Charles Schumer, has on several occasions presented to the Parks & Recreation Committee of Community

Board 8 and most recently to a joint meeting of that committee and the Traffic & Transportation Committee a conceptual study of a proposed Hudson River Greenway route connecting Manhattan and Westchester portions of the Greenway, which includes a shorter-term inland route from the Henry Hudson Bridge to the city line at Riverdale Avenue and a longer-term waterfront route from the Henry Hudson Bridge to Yonkers along the Hudson;

WHEREAS, Bronx Community Board 8 has made pedestrian and bicycle access on the Henry Hudson Bridge a community priority as stated in the 197-a plan and elsewhere;

WHEREAS, residents of Bronx Community Board 8 reject the NYMTC plan for many reasons, including but not limited to proposed widening of streets, removal of trees, loss of traffic and/or parking lanes on local streets, and locating bicycle routes in Riverdale Park, among other objections;

THEREFORE, BE IT RESOLVED That Bronx Community Board 8 makes the following recommendations:

That appropriate engineering and other studies be financed and conducted by the relevant agencies to evaluate the possibility of connecting the Hudson River Greenway across the Harlem River at Spuyten Duyvil, whether as part of the Amtrak swing bridge or on a purpose-built swing bridge, and that our elected officials assist in obtaining funding for such studies and addressing objections from Amtrak to the use of the swing bridge for the Hudson River Greenway;

That until a Spuyten Duyvil Greenway connection can be implemented, a riverfront Greenway should be established by using the existing bridge to cross the Metro-North tracks at West 254th Street, and then continuing north on the west side of the tracks to Yonkers, as envisioned in Stage Two of the NYMTC plan;

That instead of NYMTC's Stage Three plan for the Greenway route south of West 254th Street, which locates the Greenway on piers built over the Hudson River and riverbank riprap, the Greenway should be built on the west side of the Metro-North tracks on land made available by burying overhead power lines (which Metro-North has buried underground north of West 254th Street), removing Track 6, and sharing the utility road (as is done on the Greenway in lower Manhattan), to provide a less costly route than envisioned in NYMTC's Stage Three;

That until a Spuyten Duyvil Greenway connection can be implemented, the Metropolitan Transportation Authority should study the reconfiguring of traffic lanes on the lower level of the Henry Hudson Bridge to make possible a more usable pedestrian and bicycle pathway across the bridge;

That until a Spuyten Duyvil Greenway connection can be implemented, local streets only (and not the Riverdale Park right of way) should be used for Greenway bicycle connections between the Henry Hudson Bridge and W. 254th Street, under the regulation of the New York City Department of Transportation (NYC DOT);

That this resolution supersedes a resolution passed in May 2012 in which the community board called for improved pedestrian and bicycle access on the Henry Hudson bridge by reconfiguring traffic lanes on the lower level and also for consideration of a Greenway route from Palisade Avenue and West 232 Street via a bridge over the Metro-North tracks to the riverfront at the southern edge of Riverdale Park or at the DEP station located slightly farther north in the park;

That further consideration of an all-river Greenway route should continue under the auspices of Bronx Community Board 8 in cooperation with local residents, community groups, and appropriate government agencies.
