Chairman called upon Budget Chair, M. Yamagata to conduct the Public Hearing on Responses from City Agencies on the Capital/Expense Budget Priorities for FY 2018 at 7:20 PM.

M. Yamagata asked board members for their comments. S. Alexander noted that the committee's spend a lot of time preparing their budget priorities and OMB often responds as follows; that although they are in support of the requests city funded financial support is necessary to implement the request; further study by the agency is needed, they recommend the request be brought to elected officials, i.e. Borough President and/or City Council. The Housing requests had a response that the agency will accommodate this issue within existing resources. P. Ellis would want feedback with details of how and when they were accommodated. B. Bender reported that capital projects in the Parks Department come only from elected officials. \$200,000,000.00 received from the Croton Filtration Plant has been spent on capital projects for our Parks.

B. Press pointed out that wording of our budget requests should be changed from year to year.

A formal statement with the above concerns will be prepared and sent to the Mayor and the Office of Management & Budget.

Chairman Padernacht convened the meeting at 7:30 P.M.

- 1. Gallery Session
  - Aga Chen of Spuyten Duyvil Library announced that since September, 47 incidents of teen
    disturbances have occurred in the library. The teens are from the local schools. Patrons get upset and
    leave the library. They do have a security guard present. Deputy Inspector O'Toole suggested they
    meet with local Principal's and alert them of these commotions.
- 2. Introduction of Special Guests

#### Chairman Padernacht invited Councilman Cohen to address the board

- The New York City Council anticipates passing legislation that increases penalties for illegal operation of All-Terrain Vehicles (ATV's).
- The income threshold for the Senior Citizen Rent Increase Exemption (SCRIE) and Disability Rent Increase Exemption (DRIE) programs will be increased to help more seniors and disabled individuals keep their rents affordable.
- There is a Town Hall meeting scheduled with Mayor De Blasio on February 21<sup>st</sup>, 7:00PM at In Tech Academy, 2975 Tibbett Avenue.
- A bill was passed that will bar the city from instituting a five cent fee on the distribution of plastic bags.

#### 3. Report from the 50<sup>th</sup> Police Precinct – Deputy Inspector O'Toole

- Councilmembers Cabrera and Cohen funded several cameras for the district.
- Crime stats 2017 vs 2016 murder 0 vs. 1, rape 1 vs. 2, robbery 12 vs. 14, felony assaults 19 vs. 13, burglaries 16 vs. 12, grand larceny 17 vs. 42 (up 73%), grand larceny auto 6 vs. 9.
- A woman was killed while walking on the Major Deegan.
- There have been 9 arrests for mailbox fishing. This is when criminals fish out checks from the
  mailboxes; dip the checks in a solution that removes the ink, and then re-writes in a new dollar amount
  and recipient. Deputy Inspector O'Toole suggested using gel ink since it is absorbed in the paper and
  does not wash off.
- 4. Report from the Office of the Bronx Borough President No representative present
- 5. Chairman's Report Daniel Padernacht
  - Borough President's office hosted a Parliamentary Procedure presentation for community board members. They intend to host another one in the spring.
  - The Mayor laid out his accomplishments and visions at the State of the City. A good amount of the address focused on affordable housing.
  - 3061 Scenic Place issue letter was sent to Department of Investigation (DOI); inquiry to Commissioner's office about status received following response: it is DOI's policy not to comment on open inquiries.
  - The retirement party for District Manager, Patricia Manning, was a great event and the Chair thanked all of the Board members who attended and a special thanks to R. Ginty, K, Pesce and A.J. Robateau who helped organize the event.
  - The Chair met with elected officials and DOT to discuss a plan to make changes to the roadways of the Broadway corridor in order to make the passage safer for pedestrians and motorists.
  - The Chair announced the 101<sup>st</sup> birthday of Board Member Irving Ladimer. The Board wished Irving Ladimer a happy birthday and the meeting was paused for 10 minutes in order for Board members to celebrate the occasion.

#### 6. Treasurer's Report – A.J. Robateau

- The Treasurer's report was distributed. The total amount in the budget is 243,912.00. OTPS balance is \$69,272 with discretionary contributions of approximately \$10,000 from elected officials. \$49,000 is uncommitted. \$9,000 for a Hudson River Greenway consultant includes some money transfer from 2016 which is encumbered to 2017. Item #499=\$1 to keep the line item open.

# C. Economic Development – S. Villaverde

- A joint meeting is being planned in March to discuss a study of the Broadway corridor.
- The Economic Development Committee is in discussions with a consultant and other parties about establishing coding courses within Bronx Community Board No. 8 and the possibility of a Hack-athon.

#### D. Education – S. Alexander

• The next meeting is on February 28 in the board office.

# E. Environment & Sanitation – L. Spalter

- A representative from the Department of Sanitation discussed issues with step streets. DSNY is
  responsible for the steps. DOT is responsible for outside of the railings. Agencies will be brought
  together at a future meeting to move forward on this.
- Organic recycling pickup will be extended to Bronx Community Board 8 by the fall of 2017. It is now voluntary but will become mandatory in 2019.
- DSNY has a new snow plan. CB 8 has been divided into sectors. The new plan will plow all three routes within a sector at the same time.
- There is garbage dumping and graffiti along the CSX, located between Van Cortlandt Park South and West 230th Street running alongside the Major Deegan Expressway (behind Broadway stores, Stop and Shop, BJ's, etc. L. Spalter had some conversations with a representative of CSX to clean up the area.
- F. Health, Hospitals and Social Services Chair not present no report

# G. Housing – P. Ellis

- On January 30 the Housing Committee held the third part of their Housing Forum. It is on videotape and will be posted on the website.
- The next meeting is on February 27 at the Jericho Project. It will be on problem buildings and problem landlords. There will be representatives from HPD, Northwest Bronx Housing and local elected officials.

#### H. Land Use – M. Wolpoff

- 5731 Broadway will be an 83 unit building with 17 affordable apartment units.
- The Fieldston School made a presentation on their master plan.
- 600 West 246 they are reopening the resolution of the New York Board of Standards and Appeals to extend the term of a variance previously granted.
- Waiting for confirmation from the Land Use Chair on whether there will be a meeting in February.
