INTRODUCTION

The annual Statements of Community District Needs (CD Needs Statements) and Community Board Budget Requests (Budget Requests) are Charter mandates that form an integral part of the City's budget process. Together, they are intended to support communities in their ongoing consultations with city agencies, elected officials and other key stakeholders and influence more informed decision making on a broad range of local planning and budget priorities. This report also provides a valuable public resource for neighborhood planning and research purposes, and may be used by a variety of audiences seeking information about New York City's diverse communities.

This report represents Bronx Community Board 8's Statement of Community District Needs and Community Board Budget Requests for Fiscal Year (FY) 2018. This report contains the formatted but otherwise unedited content provided by the Community Board, collected through an online form available to community boards from September to November 2016.

c) Community Board Budget Requests

The final section includes the two types of budget requests submitted to the City for the FY18 budget cycle; one list for capital and another for expense budget requests. For each budget request, community boards were able to provide a priority number, explanation, location, and supporters. OMB remains the definitive source on budget requests submitted to city agencies.



3. Overview of Community District

Bronx Community Board 8 ("BXCB8" or "Board 8") includes the neighborhoods of Fieldston, Kingsbridge, Kingsbridge Heights, Marble Hill, Riverdale, Spuyten Duyvil and Van Cortlandt Village. The majority of residents are between the ages of 18 and 64. There are, however, a significant number of children and senior citizens in BXCB8.

Board 8 has various types of housing including cooperative apartments, condominium units, one family houses, 2-4 family houses and multi-family apartment buildings. Board 8 has three New York City Housing Authority Developments: Marble Hill, Fort Independence and Bailey Houses. Our community has 68 park sites, with two of the most prominent being Van Cortlandt Park and Wave Hill.

The NYCHA Developments are in need of major improvements. Our specific capital funding requests include funding for necessary work required on mechanical systems, including repair, maintenance, and replacement of heat and hot water systems and elevators. Funding for necessary exterior work, including repair, maintenance, and replacement of roofs and windows is also required. In addition, we request funding for the following: a) to maintain sufficient personnel for full staffing of all caretaker positions at Marble Hill, Fort Independence and Bailey Houses; and, b) to hire additional skilled trade workers to service Marble Hill, Fort Independence and Bailey Houses.

Our senior citizens are very important to us, and we support independent healthy living for seniors. It is our determination to ensure that all of their concerns are addressed. Accordingly, we request funding: a) to address the unique mental health issues in the geriatric community, including dementia care; b) to monitor home care firms to ensure they effectively screen, train, and supervise home attendant staff to serve clients with physical and cognitive needs; c) to fund administrative costs of outreach and home visiting programs for frail homebound adults; d) fund programs to educate community on home safety design and modifications to allow older adults to safely remain in their homes; e) to increase count-down and audible crossing signals, and longer traffic light/walk changes on wide streets, especially near locations of large senior populations; and f) to fund community based mental health services for older adults in centers and home settings.

School aged children comprise approximately 23% of our population. Our children deserve a safe and supportive learning environment, and services to promote their development. We request funding for: a) PS 37: security system, including security cameras and monitors; b) In-Tech Academy: removal of the concrete from the existing track, and replace it with a synthetic surface with a longer life, to significantly reduce the risk of student injury; c) PS 95: AC units for all classrooms and new HVAC system in the auditorium, and upgrade classroom Smart Boards; d) PS 81: AC for gym, cafeteria, and auditorium, including electrical upgrade, AC units in 12 classrooms, including electrical upgrade, and for upgrading the computer room, library and school yard; e) for the creation of rooftop hydroponic gardens in PS 24, RKA 141 and MS 368; f) to support after school and evening programs at our community centers; g) for an upgrade of security to the many parks and playgrounds in our community.

Our parks engage people of all ages, from all around the City, in healthy outdoor activities. However, many of our parks are in need of maintenance, reconstruction, and repair. We request funding for: a) the construction and related plumbing repairs in Fort Four Park, plus required maintenance; b) the redesign and reconstruction of Bailey Avenue playground; c) construction of a rest room at West 251st Street in Van Cortlandt Park, adjacent to the parade grounds; d) construction of a pond wall at Spuyten Duyvil Park to prevent water runoff from the pond; e) erosion control measures in Ewen Park to prevent runoff downhill toward Riverdale Avenue; f) reconstruction of the steps of the historic south side entrance to the Van Cortlandt House Museum; g) resurfacing of the basketball courts at Seton Park; h) renovation of Van Cortlandt Park Stadium; i) renovation of the Strong Street playground; j) sufficient maintenance personnel in our parks; k) purchase of a small tractor to aid in the maintenance of the parks; l) a stump grinder, and a replacement tractor for Van Cortlandt Park; and m) increased horticultural personnel to assist in maintaining Greenstreets.

Our libraries are an invaluable cultural and educational resource. We request funding for a) Van Cortlandt Branch: façade rehabilitation, roof replacement, general interior renovation, and d) window replacement; b) Riverdale Branch: HVAC unit replacement, ADA upgrade – ADA bathrooms, full interior renovation; Spuyten Duyvil Branch: 5,000 sq. ft. expansion, boiler & HVAC unit replacements, ADA upgrade, general interior renovation.

3. Overview of Community District

Board 8 recognizes the need of programs to deal with food waste and collection of refuse in our community. We request funding for the following: a) NYC organic composting project to support education outreach and hiring of interns at two local organizations; b) expand organic recycling in Board 8; c) increase Sanitation Enforcement's staffing for enforcement of illegal dumping and pooper scooper laws; d) purchase of SUV to transport WEP workers with equipment to areas in the community requiring maintenance; e) to remove or modify the salt shed in Van Cortlandt Park to abate pollution caused by salt leaching into the wetlands;

We request funding for Department of Environmental Protection: a) to increase resources for sewer inspections, cleaning and repair of curb drains, catch basins and sewer lines to alleviate flooding; b) construction of Daylighting of Tibbets Brook both inside and outside Van Cortlandt Park to divert and prevent billions of gallons of water from overwhelming our Combined Sewer.

Board 8 is dedicated to the promotion of public safety. We request funding for Argus cameras for the 50th Precinct, with installations recommended at the following locations: Broadway and W 225 Street; Kingsbridge and University Avenues; Webb Avenue and Eames Place; Claflin Avenue and West197 Street; Broadway and 231 Street; Broadway and West 241 Street; Johnson and Riverdale Avenues; Sedgewick Avenue, Reservoir Avenue to Fort Independence Street; Independence Avenue at West 239 Street; Sedgewick Avenue, Van Cortlandt Avenue West; Bailey Avenue, Summit Place to West 234 Street; and, Riverdale Avenue, between West 236 and West 238 Streets.

BXCB8 recognizes the need to maintain safe streets in good condition, to promote the efficient flow of traffic and transportation throughout our community. We request funding for the following: a) increase resurfacing to fifteen lane miles; b) full reconstruction of the crumbling step street at Summit Place between Heath and Bailey Avenues; c) conduct a traffic survey in the vicinity of BJ's shopping center at West 237th Street and Broadway, due to car traffic being forced to Corlear and Tibbett Avenues; c) Installation of lighting for the Kappock Street underpass; d) restore full BX 20 service to level prior to 2011 cuts.

Finally, we request funding to enhance and promote the commercial areas in BXCB8 as follows: a) study for Beautification project at Broadway West 225th Street to West 242nd Street; b) benches and bike racks in commercial corridors, and planning funds for community merchant organization.

4. Top Three Pressing Issues Overall

The three most pressing issues facing Bronx Community Board 8 are:

- Senior services
- Youth and children's services
- Other NYCHA Housing Developments in BXCB8 are in dire need of repairs and upgrades to its properties from new roofs, elevators, heating and hot water systems; and increase in buildings and grounds staffing. Additionally, surveillance cameras are needed as a measure to help thwart crime.

NYCHA: There are three New York City Housing Developments in Community Board 8: Marble Hill, Fort Independence and Bailey Houses, all of which are in need of major improvements. All of our children, families, and elderly residents deserve a safe place to live. The tenants in these developments should not have to endure another season without adequate heat and hot water, and deal with leaks from roofs that are in disrepair. Our capital funding requests include funding for necessary repairs, maintenance and replacement of heat and hot water systems, new roofs and Senior Services: We are committed to the care and the improvement of the quality of life for our senior citizens. As our population ages, more services must be provided to respond to the unique needs of our seniors. We are determined to support community based geriatric mental health services, homecare, home safety, and innovative programs at our senior centers. Youth and Children Services: Children are the largest age based population in our community. They are the future, and we have a duty to care for them. We support their development by the maintenance of decent housing, provision of supportive learning environments, and a manifest commitment to a clean, healthy, safe community. These were considered as top pressing issues because: i) the residents in the NYCHA developments are powerless to make the necessary repairs themselves to provide heat and hot water to their families in their homes, and we have a duty to provide the resources to ensure the tenants apartments are habitable; ii) the elderly have spent their lives providing for us, and we have an obligation to respect them and care for their particular needs in a timely manner; and iii) in addition to our duty to provide for their immediate needs, the example of our actions in supporting the development and welfare of our youth will promote their determination to care for our community as they mature into adults.

Health Care and Human Services



Main Issue Related to Health Care and Human Services

Programs, services or facilities for seniors

There is a pressing need for Dementia Care programs owed to the fact that Bronx Community Board 8 has high population of seniors, and there is a need for outreach programs to educate family caregivers on dementia, person centered caregiver support; and expansion of tuition assistance to allow eligible middle class participants to attend accredited social day services.

Community District Needs Related to Health Care Facilities and Programming

Funding for Innovative Services for Seniors (ISS) geriatic mental health program. Funding for Communal meal services for seniors. DFTA liaison for BXCB 8.

Community District Needs Related to Facilities and Programming for Older New Yorkers

The following programs and services are critical for Bronx Community Board 8's Aged population: Dementia Care, Homecare, Home Safety, Safe Crossings, Innovative Programming, Geriatric Mental Health services.

Community District Needs Related to Facilities and Services for the Homeless

BXCB8 does have some homeless individuals sleeping on sidewalk and park benches. They also pan handle at shopping plazas and other public areas in BXCB8. Counselors are needed to assist them with shelter resources.

Youth, Education and Child Welfare



Main Issue Related to Youth, Education and Child Welfare

Schools and educational facilities (Maintenance)

The track at MS/HS 368 is used by 1000 students. The rehabilitation and maintenance of the track will reduce the risk of student injury. The provision and maintenance of air conditioning units in our schools are needed to improve the children's learning environments. Library upgrades provide support for curriculum, instruction and specialized efforts geared to improve student literacy.

Community District Needs Related to Educational Facilities and Programs

The track at MS/HS 368 is used by 1000 students. The rehabilitation and maintenance of the track will reduce the risk of student injury. The provision and maintenance of air conditioning units in our schools are needed to improve the children's learning environments. Library upgrades provide support for curriculum, instruction and specialized efforts geared to improve student literacy.

Community District Needs Related to Youth and Community Services and Programs

Funding in the amount of \$100,000 for the after school and evening programs of the Kingsbridge Heights Community Center that provides services to over 500 young people during a regular school year. For the past 42 years KHCC has been a hub of interconnected neighborhood and family based programming, including essential youth support services during the typically unstructured out of school hours.

Sewer capacity

Upgrade infrastructure due to new developments. Increase sewer inspections, cleaning and repair of curb drains, catch basins and sewer lines to alleviate serious local flooding problems. In addition, we need to divert millions of gallons of water from overwhelming our sewer system by construction for daylighting of Tibbets Brook both inside and outside of Van Cortlandt Park.

Community District Needs Related to Sanitation Services

District 8 Sanitation requires the purchase of an SUV to enable WEP workers/interns to be transported with needed equipment to areas in the district requiring work. Funding for NYC Organic Composting project to support education outreach and hiring of interns at two local organizations - Friends of Van Cortlandt Park and Kingsbridge Heights Community Center in order to increase community participation and collection options. Funding to expand organic recycling in BXCB8's Sanitation Districts 81, and 82 that is currently in District 83. Measures needed to abate pollution caused by salt leaching into the wetlands from the salt shed in Van Cortlandt Park.

Main Issue Related to Land Use, Housing and Economic Development

Condition of public housing

The NYCHA Developments are in need of major improvements. Our specific capital funding requests include funding for necessary work required on mechanical systems, including repair/maintenance /replacement of heat and hot water systems and elevators, and funding for necessary exterior work, including repair/maintenance/replacement of roofs masonry and windows. In addition, we request funding: a) to maintain sufficient personnel for full staffing of all caretaker positions at Marble Hill, Fort Independence and Bailey Houses; and, b) to hire additional skilled trade workers to service Marble Hill, Fort Independence and Bailey Houses.

Community District Needs Related to Land Use

We need a planning consultant to work with the land use Committee to develop a responsible plan and report.

Community District Needs Related to Housing Needs and Programming

Restore HPD inspectors to FY 2009 level (25% increase of 2 additional employees), additional Enforcement Officials in Bronx office to reduce current backlogs, and better follow up of complaints against building owners. Hire 2 additional inspectors and provide vehicles necessary to reduce DOB backlog and allow for more timely attention to open complaints. Mantain full staffing of all caretaker positions at NYCHA Marble Hill Houses, Bailey Avenue Houses, and Ft. Independence Houses. Hire additional skilled trade workers to service NYCHA Marble Hill Houses, Bailey Avenue Houses, and Ft. Independence Avenue Houses. Funding for roof maintence and roof replacement at Ft. Independence Houses.

Community District Needs Related to Economic Development

A Small Business Association satellite office would encourage economic growth in our community.

Transportation



Main Issue Related to Transportation

Roadway maintenance

The roadways throughout the district are in constant need of repairs. The annual resurfacing/paving miles allocations are grossly inadequate to cover all of District 8's roadways that are in disrepair. Further, we are still playing catch-up on resurfacing requests created from pot hole conditions resulting from the harsh winter of 2014. Our community deserves to have streets with smooth surfaces to prevent risk of personal safety and vehicle damage.

Community District Needs Related to Traffic and Transportation Infrastructure

The pedestrian overpass of the Henry Hudson Parkway at West 235/236th Streets is becoming increasingly in need of reconstruction. Cement casing on the underbelly are in decay showing some of the steel reinforcement, there have been holes in the pedestrian overpass that have been patched up, and cement work on many of the stairs on both sides of the pedestrian bridge have has had to be done to fix the crumbling steps. This pedestrian bridge is used by hundreds of people every day and even more students during the school year to cross the busy HHP. Construction of a contiguous side walk north side of West 254th Street from Netherland Avenue to MTA Railroad Terrace. Construction of a walkway to connect Arlington Avenue to West 261st Street where it dead ends at the Skyview Apartment complex (about West 260th Street) reconstruction of deteriorating curbing where needed.

Community District Needs Related to Transit Services

Restore full BX 20 service to level prior to 2011 cuts. These cuts have caused a tremendous issue with overcrowding.

Parks, Cultural and other Community Facilities



Main Issue Related to Parks, Cultural and other Community Facilities

Park care and maintenance

Bxcb 8 parks are not being properly maintained due to lack of staff, and projects that are needed are not being done such as - Fort Four Park restroom reconstruction, Bailey Avenue playground redesign and reconstruction, Spuyten Duyvil Park pond wall construction, Ewen Park erosion control measures, Strong Street playground renovation, Seton Park basketball court resurfacing, and in Van Cortlandt Park the construction of a restroom at Broadway and West 251st Street (next to the parade grounds), Renovation of the steps on the historic south side entrance to the VCP Museum, and renovation of the VCP stadium which has or should be condemed.

Community District Needs Related to Parks and Recreational Facilities and Programming

Bronx Community Board 8 has a longstanding request for construction of a new restroom and related plumbing repairs in Fort Four Park, a heavily used park. Partial funding has been provided by elected officials, but more is needed. At the community's request, we strongly urge that the remaining funds needed to complete this project be granted in a timely manner to carry this project forward. We continue to request implementation of the Bailey Avenue playground redesign and reconstruction, Spuyten Duyvil Park pond wall construction, Ewen Park erosion control measures, Strong Street playground renovation, Seton Park basketball court resurfacing, and in Van Cortlandt Park the construction of a restroom at Broadway and West 251st Street (next to the parade grounds), as well as renovation of the steps on the historic south side entrance to the VCP Museum, and renovation of the VCP stadium.

Community District Needs Related to Library Facilities and Programming

Bronx Community Board 8's five branch libraries- Jerome Park, Kingsbridge, Riverdale, Spuyten Duyvil and Van Cortlandt are heavily used resource and programming centers. The libraries are home to all from seniors to students and toddlers. Funding the requests of the libraries are essential to ensure full purpose operation. BXCB8 supports the following requests for critical upgrades: Riverdale - HVAC replacement, ADA upgrade, and full interior renovation; Spuyten Duyvil - HVAC and boiler replacement, including ADA upgrade, with general interior renovation, Van Cortlandt - Façade Rehabilitation, roof replacement, general renovation, window replacement, HVAC replacement, ADA upgrade
