Lutheran Social Services, under contract with the federal Office of Refugee Resettlement, plans to provide transitional group home services for up to 22 boys and girls, ages 12-17 years old, at 2865 Kingsbridge Terrace. The young people are Unaccompanied Minors who have entered the U.S. illegally, *i.e.*, without authorized immigration status. The facility, which could begin operation as early as May 5, 2014, will be staffed 24-7 in a 1:5 ratio (staff to residents) and under digitally recorded video surveillance linked to local fire & police departments.
