Chairman Ladimer called the meeting to order at 7:30pm

Chairman Ladimer welcomed all of the members of the Committee and reminded the Committee of the provision in the Bylaws that the Chair may call an executive session so that particular considerations may be held in confidence.

The committee then discussed language, some of which had been previously considered during the October session. Chairman Ladimer noted the provision in the Bylaws that states that the Nominating Committee must consist of three or five people.

Regarding Procedures of the Nominating Committee:

The Committee considered the following language:

- 1. A Nominating Committee consisting of three or five appointed members shall be elected by the Board (Art. 5, Sec. 2, Bylaws) The Committee designates its chairperson and presents candidates for offices (officers and committee chairs) to be filled at the next election meeting. Proceedings of the Committee are confidential and not subject to outside appeal.
 - (a) Officers: A member of the nominating committee may not be nominated by the committee for a position of officer.
 - (b) Committee Chairs: A member of the Nominating Committee under consideration for a committee chair shall recuse himself or herself from

discussion or vote if there is another candidate. The Committee may recommend one or both to the Board without prejudice.

The proposal that the proceedings of the Nominating Committee are confidential and not subject to appeal were struck on the ground that the Committee could act without any further instruction or restriction.

Chairman Ladimer proposed to condense 1(a) and 1(b) by adding "or committee chair." to the end of section 1(a).

The **YEAS** being **6**: Mr. Ladimer, Mr. Cohen, Mr. Spett, Mr. Marquez, Ms. Feldmeier and Ms. Ginty.

The NAYS being 5: Ms. Pilsner, Ms. Khury, Mr. Press, Mr. Parker and Mr. Fanuzzi.

The **ABSTENTIONS** being **1**: Mr. Padernacht.

The proposal failed for lack of a majority.

The original language, proposed at the October session was sustained by unanimous consent.

Ms. Ginty proposed to amend the language of 1(b) to read as follows:

"(b) Committee Chairs: A member of the Nominating Committee under consideration for a committee chair shall recuse him/herself from discussion and vote for that position."

The **YEAS** being **8**: A. Spett, S. Marquez, R. Ginty, I. Ladimer, D. Padernacht, R. Press, J. Pilsner and A. Feldmeier.

The **NAYS** being **4**: A. Cohen, M. Khury, L. Parker and R. Fanuzzi.

Abstentions being 0:

The language was adopted.

Mr. Fanuzzi suggested that the Committee should conduct research and present a report on the nominating practices of other community boards. Ms. Pilsner disagreed.

The meeting was adjourned at 9:10 pm.
