Minutes of the Joint Economic Development and Libraries & Cultural Affairs Committees meeting of January 24, 2008 Page 2

Vice Chairperson R. Fanuzzi gave a brief synopsis of the Economic Development committee's vision to bring a Cultural Trolley service into the confines of Community Board 8 which would showcase the various cultural institutions located throughout our community.

Guest Speaker: Ellen Pollan, Director of the South Bronx Corridor Trolley Program

- Ellen Pollan's presentation was focused on the operation of the Bronx Corridor Trolley program. The Trolley program runs through the South Bronx to pull together the cultural programs of the various institutions in the community. The Trolley, which seats 35, is owned by the Bronx Tourism Council (BTC). The operating times vary with each program or rental which starts at \$150 per hour inclusive of insurance, driver, etc. Evening rental for 4 hours is \$300.00. The cost to run the Trolley under the South Bronx Corridor Trolley program is approximately 150K. Some funding obtained through grants and various bank foundations.
- Discussion had on how a Trolley program could be instituted in Community Board 8. Suggestions of either a new umbrella organization or several long standing non-profit entities in the community could be candidates to start, run and operate the program. A Trolley program will help to bring economic development to the community.
- Discussion had on some considerations: Who is the target audience, How do you get people to partake in Trolley services, Advertisement and Marketing...etc.
- Doris Quinones and Janet Florindo, both from BTC joined the discussion. BTC currently has one (1) Trolley and in the process of obtaining another one.
 Reiterated rental price of Trolley. Advised one of the most important thing is to give the Trolley audience a positive visitor's experience. The top priority to the Council is that the goals of economic development, cultural, and tourism of the Bronx are met.
- Ideas were introduced: Buy a button to hop on and off and go around on the trolley, Possibility of holiday or late evening Trolley events, Use of the Trolley for the aging members of the community to bring them to the shops in the community....Discussions as to the use of the Senior trolley or the Commercial trolley discussed previously in the Economic Development committee and will continue in future meetings.
