The meeting was called to order at 7:35 PM. Committee members and guests signed the attendance sheet on arrival. The meeting is started by committee members and guests introducing themselves and their affiliation. The previous committee meeting minutes was approved:

For over 2 to 3 months the board office has received numerous complaints about rat infestation from community residents who have either called or sent emails to the board office. The residents were then redirected to call 311 and file a report and get a ticket number so the board office can then expedite this issue with the departments of health and sanitation. There have been numerous sightings of rats at 2287 Johnson Ave, Cannon Place and Jerome Park Reservoir.

The Bronx Borough Coordinator for the Department of Health Mrs. Erica Peralta-Downing begins by explaining the procedures for rat infestations as follows:

- 1. The Health Department must receive a complaint with the address of the infestation.
- 2. There will be a first initial inspection
- 3. Then a second inspection, if the second inspection fails, the owner of the property will be issued a summons.
- 4. fines for failure to comply with summonses can range from \$300 to \$2000.
- 5. If the owner of the reported property hires a pest control agency before the case is heard the case will be dismissed.
- 6. If the Department of Health conducts the clean up the owner will be billed the total cost for the clean-up.

Bronx Community Board No.8 Vice Chair Laura Spalter states that rat infestation has been present around and within construction sites in CB8 and this is due to the garbage that has been left over. Spalter also states that the Environment and Sanitation Committee will be creating a resolution for the E/S Committee and the entire Board to vote on to require rat abatement materials at construction sites within CB8.

Rats can only reproduce with food and garbage. Rats tend to seek out places to live that provide them with everything they need to survive such as food, water, shelter and safe ways for them to get around. To keep rats out of your property or neighborhood, residents can take steps to make life more difficult for rats such as:

- Clean up. Garbage and clutter give rats a place to hide.
- Rats eat your garbage, so store all garbage in hard plastic rat-resistant containers with tight fitting lids.
 Provide enough trash containers for all of the occupants of your property. Any exposed garbage will attract rats.
- Keep landscaped areas around your property free of tall weeds and trim shrubs that are close to the ground.
- Check for cracks or holes in the foundation of your building, sidewalk and under doors and repair them by filling and sealing them.
- On the street or in a park, put your litter in a can and do not feed birds or other wildlife.

Miss Martha Morales states she is the Coordinator of the Department of Health Rat information Portal (Rate Portal) which Provides the information on:

- Rat inspection Records
- Tips on preventing rat infestations
- Instructions for responding to an order from the Heath department for a failed inspection
- Tips for finding a license Pest Control Professional

Morales explains that the department has a free Rat infestation prevention training course to residents and the community which is called the Rat Academy. DOHMH Reps states they would be willing to do this training in collaboration with CB8 all is needed is a space that can hold 20 or more people. The Committee Chair states he will be willing to do this training session and will work with DOHMH after the winter season to conduct this training session. The DOHMH Reps thanks for Committee for inviting them and states more information concerning rats infestation is located at www.nyc.gov/rats.

Gabrielle Milner of Montefiore Hospital explains that the Bronx Oncology Living Daily (BOLD) is outpatient wellness and support program that are available to anyone that is affected by cancer which can be patients, family members and caregivers. Milner states 1 in 8 women will develop cancer and 1 in 833 has cancer in the Bronx.

The Bronx has a higher rate of late stage cancer because of many barriers. Black men tend to have a higher rate of cancer, early signs of cancer in men include the following:

- Changes in bowel habits.
- Urination difficulties.
- Weight loss.
- Testicular changes.
- Breast lumps.
- Skin and mouth sores.
- Persistent cough.

Stomach pain and nausea.

The BOLD Program includes the Following:

Bronx Oncology Living Daily / BOLD Living

This program offers a monthly schedule of wellness workshops that are designed to empower, nurture and connect those affected by cancer. Topics include fitness, nutrition, drum circles, crochet, creative arts, Reiki healing, and more.

Psychosocial Oncology Counseling

Free one-on-one counseling and support groups for cancer patients, survivors, family members, and those in bereavement from a cancer-related loss. Services are provided by counseling interns who speak English and Spanish.

Mind-Body Support Group

This support group offers a safe place for patients in advanced treatment to share their thoughts and feelings, learn how to cope with daily challenges, and connect with others who may be going through the same things.

Yoga-Based Cancer Rehabilitation Study

Yoga classes are offered weekly to patients with breast, lung or colorectal cancer, as part of a research study for people with cancer who are eligible.

BOLD Buddies

Volunteers in this program are available to provide companionship and support to isolated cancer patients at medical appointments or by telephone.
