Vice Chair Khury convened the meeting at 7:35 PM.

Vice Chair Khury informed that Chairman Fanuzzi was away at a work conference in Paris.

## PUBLIC HEARING: Capital & Expense Budget Requests for Fiscal Year (FY) 2015

Vice Chair Khury deferred to Budget Chairman Contant to convene the public hearing on the Board's Budget Priorities for FY 2015.

Budget Chairman Contant thanked the Committee Chairs for their work with development of the committees Budget Priorities requests for FY 2015, and he thanked District Manager Stent for her involvement and attendance at budget consultations and assistance with the priorities. He referred to the list of both Capital and Expense budget priorities which had been reviewed by the Executive Committee and distributed to the full Board. The priorities ranking of the 25 Capital budget requests and the 19 Expense budget requests were reviewed and discussed. Following, there was agreement to provide a higher ranking for the request for an EMS restocking and decontamination station which was switched from 19 to 10 under Capital.

The Budget Chairman opened the floor to the public for anyone wishing to give testimony on the FY 2015 Budget requests. He called upon Rebecca Barbier, representing New York Public Library (NYPL).

R. Barbier thanked the Board for having listed library budget priorities amongst the top five Capital Budget items. She discussed NYPL's budget requests and distributed the list of priorities which were mostly contained in Bronx Community Board No. 8's Capital Budget Priorities for FY 2015.

Not hearing from any additional speakers, Budget Chairman Contant closed the Public Hearing and called for a vote on the Capital and Expense Budget Priorities for FY 2015 as amended (attached). The motion was seconded and the following vote resulted:

## 1. Gallery Session

- A. Herb Barret, reported on the Memorial Grove's one and a half year anniversary restoration. He invited all to the annual Veterans Day Ceremony on November 10, 2013, at 12:00 PM being held at the Grove at West 246<sup>th</sup> Street and Broadway.
- B. Leslie Hogan, a member of Broadway Community Alliance discussed opposition to the Selfhelp development at 6469 Broadway that had included a population of seniors with mental

illness mixed with well elderly. She thanked the Community Board, and elected officials, for their responsiveness to the community residents in working together to oppose the component of an unstable mental population. She spoke about the news conference held by Senator Klein where he announced that due to community opposition, Communilife, who had partnered with Selfhelp to provide housing to seniors with mental illness, had withdrawn from the project. However, Ms. Hogan stated that there are still some issues with the plans and asked that the Community Board and elected officials continue to work with the Alliance for development of the property in an appropriate and responsible manner.

- C. Fran Garfinkel advised about upgrades needed at the Seton Park dog run. The users are a group of 50 and have already raised some funds. Improvements needed include a gate, a fence and removal of tree roots that are hazardous to dog owners. Dog waste disposal bags are also needed.
  - B. Bender invited the group to attend the next Parks and Recreation Committee meeting to discuss the issues.
- D. Susan Corber spoke about opposition to paving the Putnam Trail. She reviewed the high cost of maintaining the paved trail. Ms. Corber urged Community Board 8 to preserve the 1.5 miles natural Putnam trail that remains.
- E. Roberta Strugger spoke on behalf of dog owners who use the Fort Independence Park dog run. She reported that the dog run was recently locked without notice to the community since construction started on the Jerome Park Reservoir jogging trail, nor has an alternate space been offered. She asked for Community Board 8's support to extend the trail through the park.
  - D. Padernact suggested clarifying those issues with B. Fanuzzi who sits as Chair on the Croton Filtration Monitoring Committee. B. Bender advised that he was not aware that the dog run had been shut and would check with the Parks Department the next day.
- 2. Approval of Regular Board Meeting Minutes of September 11, 2013

The minutes were approved unanimously.

- 3. Discussion of Executive Committee Meeting Minutes of October 2, 2013
  - M. Heller referred to his comment under New Business concerning favoring one venue for Board meetings. He will send a statement to be included in the minutes explaining why he thinks this is a good idea.
  - R. Press referred to New Business, 2<sup>nd</sup> bullet. He apologized and took responsibility for the lack of submission of any Traffic & Transportation Committee minutes which he recorded and failed to provide to D. Padernacht.
  - M. Wolpoff referred to the Land Use Committee report, page 3. He advised that his name
    was omitted as being an attendee at the meeting concerning Selfhelp's project at 6469
    Broadway held with the Borough President. M. Khury stated it will be added.
- 4. Vice Chair Khury welcomed and invited Captain Paul Rasa, new 50<sup>th</sup> Precinct Commander to address the Board.

Captain Rasa advised that he was recently assigned to the 50<sup>th</sup> Precinct. He provided information on his background and advised that he is a 20 year veteran of the police force. His command has 150 officers. Captain Rasa reviewed the year to date crime stats as follows:

murder: 2 vs. 4 last year; rape: 1 vs. 7; robbery: 113 vs. 108; felony assault: 114 vs. 97, burglary: 118 vs. 144, grand larceny: 307 vs. 318; grand larceny auto 68 vs. 76; and transit crimes: 7 vs. 11. Overall crime is down 4%. He warned of active cell phone and IPhone snatching patterns on Manhattan College Parkway late nights and during the daytime in the area of Reservoir Avenue. 1,100 arrests have been made year to date.

5. Vice Chair Khury invited Assemblyman Jeffrey Dinowitz to address the Board.

Assemblyman Dinowitz announced the schedule for the annual Free Flu Shots: October 10, 2013 at St. Gabriel's School; October 17, 2013 at Vladek Hall; and October 28, 2013 at Riverdale YM-YWHA. He discussed new construction projects across the community and asked the Board to be vigilant in making sure that zoning compliance is in order.

- 6. Report from the Office of the Bronx Borough President A. Toledo
  - With regard to the recent violent tragic incident with a motorist and bikers on the Westside Highway, Borough President Diaz, Jr. is proposing legislation to prohibit refueling of "dirt bikes" at gas stations. The gas station owners will be held in violation for allowing the refueling.
  - The 19<sup>th</sup> Annual Tour de Bronx will be held October 27, 2013. Register at ILovethebronx.com.
- 7. Chairman's Report Vice Chair Maria Khury
  - The Chairman's report is contained in the Executive Committee minutes.
  - Vice Chair Khury added information regarding the press conference held on October 3<sup>rd</sup> for the installation of security cameras at Marble Hill Houses, and the Street Co-Naming Ceremony for James Downey held on October 5<sup>th</sup> on Mosholu Avenue between West 254<sup>th</sup> and 255<sup>th</sup> Streets.
  - B. Contant and P. Friedman discussed the online presentation given at the Executive Committee meeting and distributed to the Board. They are working on developing a method of using electronic media for the benefit of broadcasting important issues to the Board's constituents. The aim is to build an email database. Volunteers for this project are welcomed. P. Friedman has already contacted other community boards throughout the city to gather input on systems they use for providing information to the community. There have been three replies thus far and one, Brooklyn Community Board 6 had a very interesting response. The responses will be forwarded to the Board.

The District Manager's report is contained in the Executive Committee minutes. She highlighted the FY 2015 Bronx Borough Consultations that had occurred.

  - Vice Chair Khury extended special appreciation to A. Cohen, for his past service as Committee Chair of the Aging Committee.
  - Vice Chair Khury opened the floor for nominations for the Chair of the Aging Committee. I.
     Ladimer nominated K. Pesce and she accepted. The nomination was seconded. Hearing no

other nominations, the nominations were closed. A vote was called for the election of K. Pesce. The vote was unanimously in favor.

- 2. Announced that Irving Ladimer will make a presentation on the US Constitution at the Riverdale YM-YWHA on October 23<sup>rd</sup> at 10:00 AM. All are invited.

#### B. Libraries and Cultural Affairs - M. Goodman

- 1. The Committee will meet on October 10, 2013, at the Board Office, at 7:00 PM.
- 2. The new NYPL Library Director for district 8 will be in attendance to present on new features. The Library Managers will provide updates on new programs. M. Goodman emphasized that libraries are no longer just about books.

## C. Parks and Recreation – B. Bender

On September 23, 2013, the New York State Department of Environmental Control (DEC) held a public hearing on the Putnam Trail to determine whether or not a wetland permit should be granted which is needed for the renovation of the trail. The hearing was held at Lehman College. There was a good turn out with over 45 speakers. The majority of speakers gave their support for paving the trail.
- 2. The Committee met on September 30, 2013 and Ewen Park was discussed. See Committee report.
- 3. On October 5<sup>th</sup> a street naming ceremony was held for James Downey on Mosholu Parkway between West 254<sup>th</sup> and 255<sup>th</sup> Streets. Over 200 people were in attendance.
- 4. The next Committee meeting will be held on October 23, 2013 at the newly renovated Van Cortlandt Park Golf House, at 7:00 PM. The Master Plan for Van Cortlandt Park will be discussed.

# D. Public Safety - A. G. Feldmeier

 A. G. Feldmeier will be speaking with the director of the Children's Aid Society to discuss their "Unsung Neighborhood Heroes" program which recognizes merchants that refuse to sell alcohol to minors. She is planning to work with the police for recommendations of worthy merchants deserving awards. She thanked Vice Chair Khury and S. Froot for informing her about the program.
