The meeting was called to order at 7:05 PM. A quorum was not met.

Board chairwoman Ginty and Mr. Fanuzzi led a discussion of the Final Report of the Special Natural Area District Working Group.

Tuton Horstman of the Department of City Planning presented on the proposed changes to the Special Natural Area District law. Please contact the board office for further information.

- 3. Ms. Sharia Paulson, former Chairwoman of the Landmarks Preservation Commission, spoke regarding the detrimental effects of the expansion of changes by right for sites under one acre.
- 4. Jennifer Klein, the leader of the Riverdale Community Coalition, spoke regarding the need to divide the SNAD review process between sites in the Bronx and Staten Island and solicit greater community input.

- 5. Steven Nelson, the Vice-President of the Fieldston Property Owners Association, spoke against the expansion of changes by right for sites under one acre 6. XXXX spoke regarding the expansion of by of right changes for certain sites over 10,000 square feet.
- 6. Ann Schuman spoke regarding the detrimental effects of removing community control for sites under one acre.
- 7. Stephanie Coggins spoke regarding the failure of the Department of Buildings to adequately respond to community concerns and thus the detrimental effects of expanding their authority.
- 8. Jonathan Sheppin spoke regarding his personal experience with the SNAD and landmark review process and elements of the proposal he deemed onerous.
- 9. Thomas Bird spoke regarding the expansion of the Department of Buildings' authority in light of their previous record in the community.
- 10. Meryl Nadel spoke on behalf of the Riverdale Nature Perservancy concerning the expansion of by-right changes
- 11. Steve Goldberg spoke regarding the need to retain community oversight.
- 12. Alexander Alexandrov spoke regarding incompetence in the Department of Buildings.
