Gaelic Athletic Association, 201 West 240th St.

Larry McCarthy, GAA Executive Committee represented the restaurant.

Gaelic Park has been operating at the location for 98 years. They operate on weekends for special events through September, from 1PM – 10PM. During the winter they have banquets. Detective Inspector O'Toole asked that they let them know when their events are so they can have an officer patrol the area.

New Applications

Amor Eterno, 308 West 231st Street

Mr. Adrian Hernandez represented the restaurant. His sister, Maritza Hernandez is the owner. Opened 3 months ago. It's an eat-in restaurant, 5 to 6 tables (19 chairs). They plan to be open until midnight or 1am. Chair Yamagata reminded them of the stipulation that during their first year they must close by 2 am and they agreed to that.

The vote to approve the license is contingent upon meeting the statutory requirement that they are not within 200 feet of a school.

In favor of approval pending the school distance stipulation: Unanimous (M. Yamagata, M. Donato, D. Escaño, M. Joyce)

Benjamin Hoff and Parilla Latina were not present.

Fire Department Presentation

Frank Manetta of the Fire Safety Education Unit gave a presentation.

- He informed us of a program called Sound the Alarm, which, in partnership with the Red Cross installs alarms for seniors free of charge.
- Replaceable battery powered smoke/CO alarms are being phased out. The law now requires 10-year sealed alarms to be installed.
- Con Ed is offering natural gas detectors.
- Mr. Gellman stated that there is a requirement for tenants to provide keys to the super or doorman to use in an emergency.
- Mr. Press commented that there are ratings for fireproof buildings: rated 1 to 4 hours

New Business

Mr. Press expressed concern about the new DOT street markings at 246th and Broadway. He said they made 5 lanes into 4 with an unprotected bike lane in the middle. There was clarification that the bike lane crosses Broadway at Manhattan College Parkway. DI O'Toole believed this might be a dangerous spot and he will look into it, as will committee chair Mary Yamagata.

With no further business to conduct the meeting was adjourned at 8:35 p.m.
