I. JENNIFER SCARLOTT SPOKE ON BEHALF OF NORTH BRONX RACIAL JUSTICE; 80 MEMBERS INCLUDING HOUSES OF WORSHIP; REPORTED CONCERNS OF EXCESSIVE FORCE USED DURING AN ARREST ON OCTOBER 6, 2017. IAB AND CCRB ARE INVESTIGATING; SPEAKER WANTS PUBLIC SAFETY COMMITTEE TO CONDUCT AN INDEPENDENT INVESTIGATION. IN ADDITION, SPEAKER WANTS INSPECTOR O'TOOLE TO STEP DOWN AND THE OFFICER INVOLVED TO BE FIRED AND PROSECUTED.

MR. WILLIAMS STATED SCARLOTT HAS ALREADY DECIDED CULPABILITY.

MR. PRESS STATED THE COMMITTEE HAS NO AUTHORITY TO INVESTIGATE; THAT THERE IS A PROCESS; CCRB AND MAYOR'S OFFICE.

MS. CORBER EXPRESSED CONCERNS ABOUT THE VIDEO; WANTS THE COMMITTEE TO FOLLOW THE ISSUE AND STATUS OF THE INVESTIGATION

MS. WOOLRICH EXPRESSED CONCERN AS TO HOW OBJECTIVE THE INVESTIGATION CAN BE SINCE MEMBERS OF IAB AND CCRB ARE APPOINTED; SUPPORTS AN INDEPENDENT INVESTIGATION; "DOESN'T SEEM LIKE DUE PROCESS".
