#### 5. Presentation by SLA on Liquor License Process (given after the SLA renewals were reviewed)

Speaker said that the NYPD sends reports to SLA, and the reports are kept on file. The speaker is familiar with Barcelona Bites. He said the administrative process takes up to a year and a half to address.

There is a public search functionality on the SLA website to find out if an applicant has other liquor licenses. Asked for clarification: the 500 foot rule is if there are 3 bars already within 500 feet of the new establishment, the 4th place has to show it is operating in the public interest, e.g., if ethnic restaurant with different type of cuisine. The 200 foot rule states that a liquor license may not be granted if the establishment is within 200 feet of a school, with the following exception: if the school is located in a mixed use building the 200 foot rule does not apply.
